Article 10(3) point 1

- Article 10. (Central online collection system)
 - §3
 - o Point 1

"Within one month of the registration of an initiative, and at the latest 10 working days before the start of the collection period, the group of organisers shall inform the Commission whether it wishes to use the central online collection system and whether it wishes to upload the statements of support collected in paper form."



Article 12(3) point 1

- Article 12. (Procedure for the collection of statements of support)
 - §3
 - o Point 1

"The Commission shall submit the statements of support collected online through the central online collection system as well as those collected in paper form and uploaded pursuant to the second subparagraph of Article 10(3) to the competent authority of the responsible Member State."



Article 12(3) point 2

- Article 12. (Procedure for the collection of statements of support)
 - §3
 - o Point 2

"Where a group of organisers has collected statements of support through an individual online collection system, it may request the Commission to submit these statements of support to the competent authority of the responsible Member State"



Summary

<u>For every successful initiative</u>, the Central Online Collection System submits the statements of support to the Member States for:

- Electronic statements of support of Initiatives using the Central Online Collection system.
 - → **ALWAYS** (art 12(3).1)
- Electronic statements of support of Initiatives using an Individual Online Collection system.
 - → At Organiser's request (art 12(3).2)
- Paper form uploaded to the central system.
 - → At Organiser's request both for the organisers using the central or individual systems -> art 10(3).1 & art 12(3).1) 6

Article 12(3) point 3

- Article 12. (Procedure for the collection of statements of support)
 - §3
 - o Point 3

"The Commission shall submit the statements of support in accordance with the second to fourth subparagraph of paragraph 2, using the EU file exchange service referred to in Article 4(5)."



Article 4(5)

- Article 4. (Procedure for the collection of statements of support)
 - §5

"The Commission shall develop a EU file exchange service for the transfer of statements of support to the competent authorities of the Member States, in accordance with Article 12, which guarantees the confidentiality, integrity and authentication of the transfer, and make it publicly available and free of charge."



Impact on Citizens

No need to contact 28 different administrations when submitting their statements of support. Only one point of contact.

Impact on Commission

Use of the EU File Exchange Service to submit to Member States:

- The electronic statements of support collected via the central Online Collection System (art 12(3).1)
- All other statements of support uploaded by the organisers either paper forms or collected electronically by the Individual Collection System (refer previous slides, art 10(3).1 & art 12(3).1, art 12(3).2)

 A secured and reliable channel to receive the statements of support

Article 12(5)

- Article 12. (Verification and certification of statements of support by the Member States)
 - §5

"Statements of support which have been collected online shall be submitted following an **electronic schema** made publicly available by the Commission"



Electronic Schema

Similar to the one existing for OCS and published in Join-up (xsd file)

Benefit for Member States

- Mandatory use of this schema for electronic statements of support, i.e. uniform for all initiatives.
- Facilitate verification of statements of support (predictable file structure).
- Lower the cost of verification.
