#### Procedure to activate an eID

- 1. The **MS** notifies its elD.
- 2. The **EC** adds the MS notified eID in the Commission eIDAS proxy.
- 3. The EC ECI team activates the elD on its Acceptance environment.
- 4. The EC ECI team contacts the MS for testing the support via elD.
- 5. The MS supports with eID on the Commission Acceptance environment.
- 6. The **EC** activates the elD in production.

# Test campaign on the file exchange service 2020

Start date: 02/10/2020 – End date: 06/11/2020

#### **OBJECTIVES:**

Ensuring Member States are ready for performing their ECI obligations of validating Statements of support:

- 1. Member States credentials are still valid
- 2. Member States contact points are still active
- 3. Tools and Processes are working



#### Notification process

- MS contact point for the file exchange service should have received a notification message on the 02<sup>nd</sup> or 05<sup>th</sup> of October.
  - This notification message contains a link to a document to download in S-CircaBC.
  - This document describes the instruction to follow to perform the test.
- A follow-up email has been sent by the Secretariat General
  - For those who have not received the notification (e.g. contact person obsolete)
  - Containing all instruction for the test campaign
  - Manuals for newcomers




# Test campaign status (22/10/2020)

14 MS who completed the test: AT, BE, BG, DK, ES, GR, HR, HU, IT, LU, NL, RO, SE, SI

4 MS in progress or in contact with the Commission: DE, FR, IE, PL

No news from 9 MS: CY, CZ, EE, FI, LV, LT, MT, PT, SK





### Test campaign lessons learned

- 4 MS requested to re-upload their credentials.
- 4 MS requested to add/remove a contact person in its group.
- 5 MS requested support from the Commission.
- **9 MS did not react after** 3 weeks (regulation obliges to validate the statements of support within 3 month).



### Next test campaign

Will depend if there will be a successful initiative requesting to use the file exchange service?

- If yes, no test campaign will happen. The test is replaced by dealing with a real initiative
- If no, it will happen between 9 and 12 month after the last activity.



### New version of the Crypto tool

Version 1.2.4 of the crypto tool has been released:

- Available in Joinup
- New Features



- Not mandatory to install this new version of the tool. The files encrypted with the previous version can be read with this new version 1.2.4.
- In case you want to install this new version of the tool, it is recommended to keep your old credentials. If you generate new credentials, immediately communicate them to the Commission (<a href="mailto:DIGIT-ECI@ec.europa.eu">DIGIT-ECI@ec.europa.eu</a>)

### Credentials Management

Changing your credentials of the crypto tool.

- If you change your credential of the crypto tool, immediately inform the Commission and send to <a href="mailto:DIGIT-ECI@ec.europa.eu">DIGIT-ECI@ec.europa.eu</a> your new credentials.
- The Commission will upload your new credentials to the File Exchange Service. The \_PUBLIC\_KEY Folder is only in read-only mode for Member States

Commission recommends that you keep for at least 2 years any version of your credentials.

• So if you have changed 3 times your credentials over the last 2 years, you should keep the folders to restore them in the new instance of the tool.
