Initiatives status since last Expert group


- 2 initiatives closed claiming more than 1 million supports

Since the start of new ECI regulation:


- 16 initiatives out of 22 chose the Central Collection System

As soon as they will be integrated in the E.C. eIDAS proxy connector (EU login) we will start the process to offer them to citizens of that nationality





Context

- Two initiatives used the File Exchange Service to submit their online supports to Member States for validation:
 - « Save Bees and farmers »
 - Registered under ECI Regulation 211/2011
 - Individual Collection System
 - Submitted on 07th March 2022
 - 2. « Stop Finning »
 - registered under ECI Regulation 2019/788
 - Commission Central online collection system



Main experiences

For initiatives using COCS:

- Transfer process via File Exchange Service performed very smooth
- Organisers only need to upload their Annexes V (and paper statements if they have chosen to use FES for those as well)
- For initiatives using individual online collection system,
 - Transfer process via FES is technically more complex organisers must first manually encrypt SoS before uploading in FES. Quality checks therefore not possible for Commission before transferring to MS.
 - Issues faced by some Member States to decrypt and validate the online statements that were solved afterwards by cooperating with Organisers



Lessons learned

- Process went fine. MS were well prepared thanks to their general rehearsal with Cohesion Policy and previous test campaign.
- "3" MS certificates had to be renewed (vs 4 Cohesion policy).
- Slowness of the crypto tool to decrypt big files faced by some Member States (e.g. Germany)
- Transfer process of online signatures smoother for initiatives using COCS vs.
 IOCS
- Reminder: From next submission to Member States, all initiatives will have been registered under ECI Regulation 2019/788 and the format of the transmitted xml file to MS will have to follow the schema defined by European Commission.

Follow-up action

- Files encrypted with the Central Online Collection system will now be zipped before encryption and submission to Member States
 - Reduce file size by 10 times
 - MS will only need to unzip the file to access the statements of support
- This implementation is already implemented and will be used for the upcoming transfer of the initiative SAVE CRUELTY FREE COSMETICS -COMMIT TO A EUROPE WITHOUT ANIMAL TESTING



Reminders / suggestions

- Annex VI
 - Stick to the official certificate format of the ECI regulation
 - Upload your Annex VI in the File Exchange Service as a matter of good practice
 - Attach your own national decision or motivation with further details on used methodology and findings'
 - Save Bees was the last initiative that was registered under the old ECI Regulation. From now onwards, the MS shall use the new annex VI when confirming the number of valid statements of support
- Try to start the download and decryption process as soon as you receive the files to raise any impediments preventing for a validation within 3 months.
- Feel free to give further feedback based on guidance note, preferably through the MS questionnaire
