Republic of Cyprus

1. COUNTRY HIGHLIGHTS

More than eight in ten respondents in Cyprus believe climate change is a 'very serious' problem (83% vs the EU average of 79%), an increase of seven percentage points (pp) since 2017. The proportion who consider climate change to be the single biggest problem facing the world has almost doubled to 14%, though remains below the EU average of 23%.

More than six in ten say that they have personally taken action to fight climate change in the past six months, an increase of 8 pp, to 62% (vs the EU average of 60%). However, when given specific examples of climate actions, this rises to 91% (vs the EU average of 93%).

- Respondents in Cyprus are much more likely to say that they try to cut down on their use of disposable items, (67% vs the EU average of 62%), an increase of 27 pp since 2017. There is also a significant increase in the proportion who take lower energy consumption into account when purchasing appliances an increase of 14 pp to 55%, (vs the EU average of 48%).

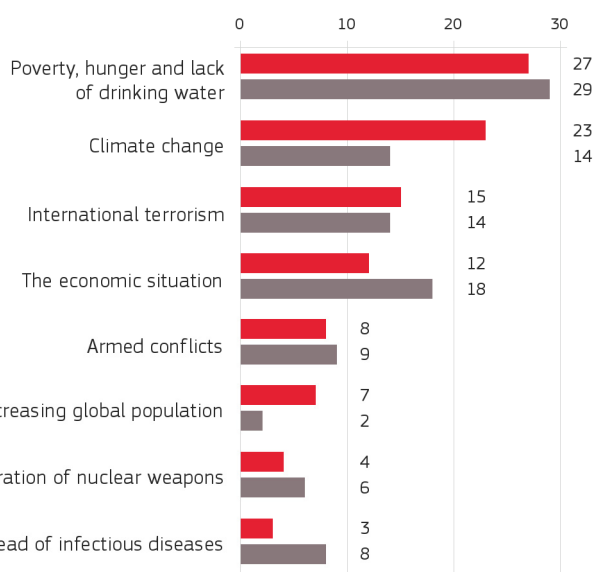
Respondents in Cyprus are more likely to agree that taking action on climate change will lead to innovation and more competitive companies (90% vs the EU average of 79%), and that more public financial support should be given to the transition to clean energies an increase of nine pp to 95%, (vs the EU average of 84%).

The proportion who agree that adapting to the adverse impacts of climate change can have positive outcomes for citizens in the EU is 75%, above the EU average of 70%.

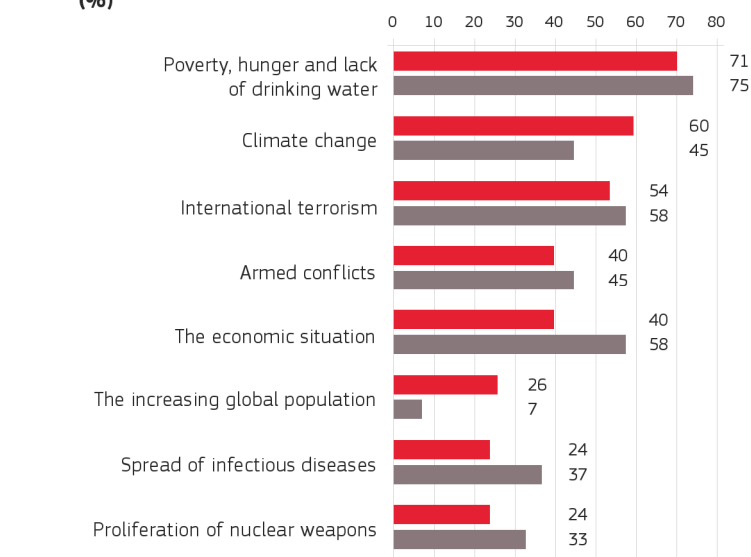
Almost all respondents in Cyprus think it is important that their government sets ambitious targets to increase renewable energy use (98%, above the EU average of 92%), and provides support for improving energy efficiency by 2030 (98% vs the EU average of 89%). Almost all respondents agree that the EU economy should be made climate-neutral by 2050 (98%, above the EU average of 92%).

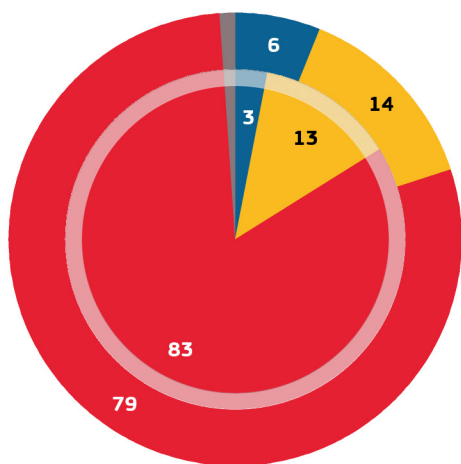

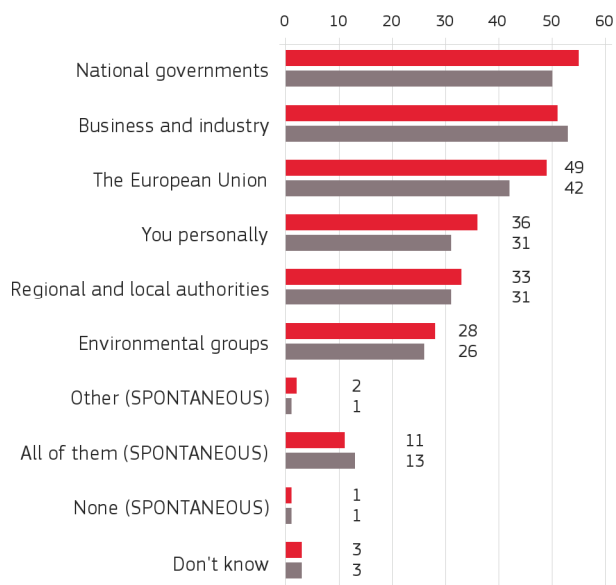

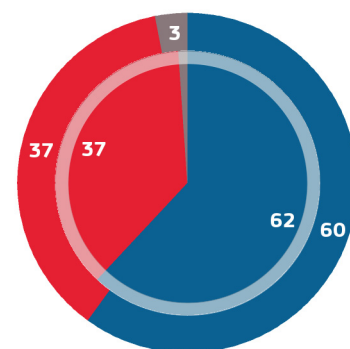
QB3 In your opinion, who within the EU is responsible for tackling climate change? (MULTIPLE ANSWERS POSSIBLE)

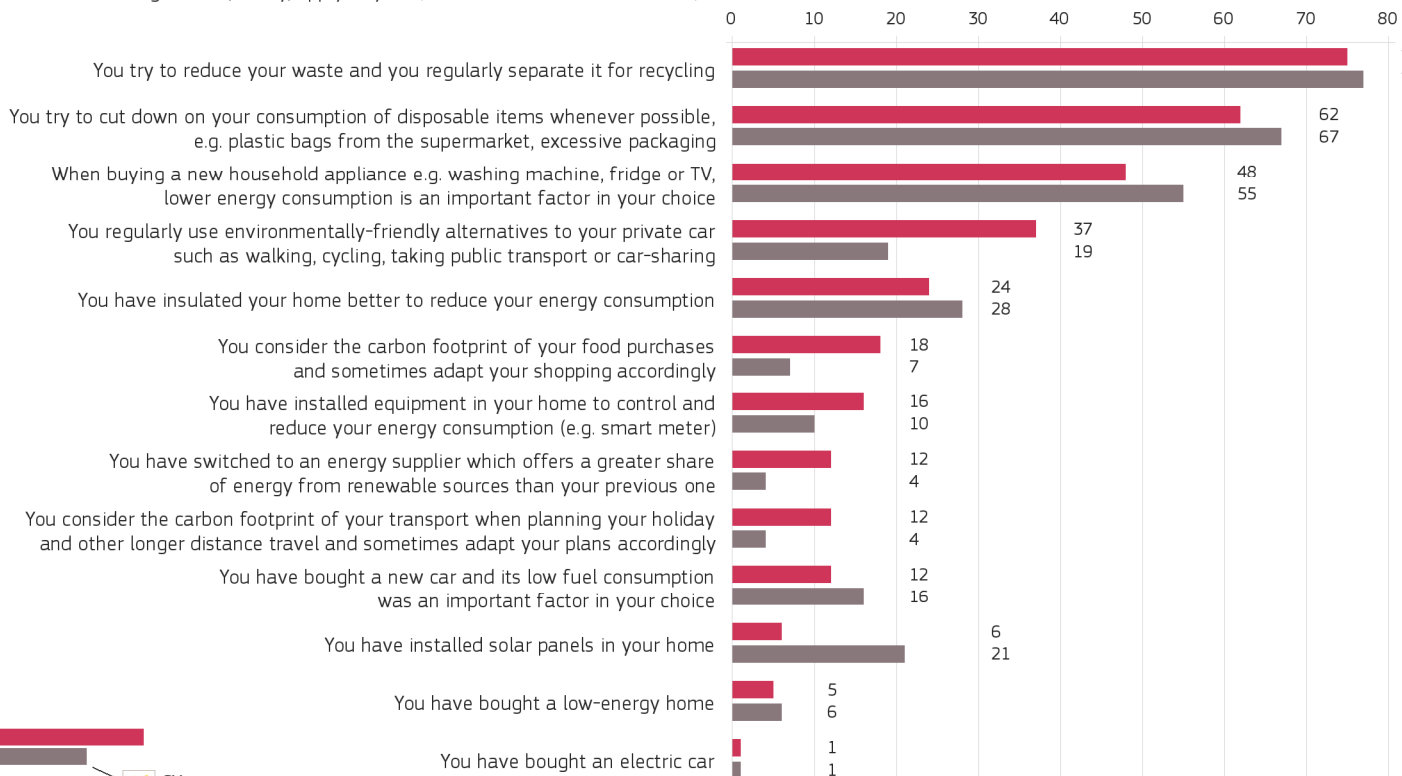

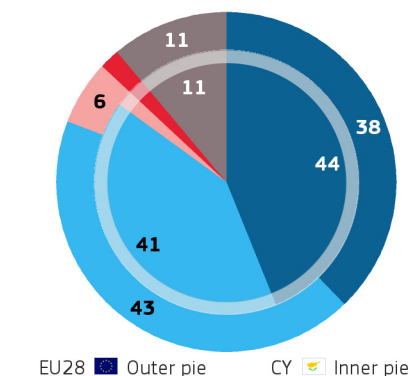
QB6 Which of the following actions, if any, apply to you? (MULTIPLE ANSWERS POSSIBLE)

Promoting EU expertise in new clean technologies to countries outside the EU can benefit the EU economically (%)

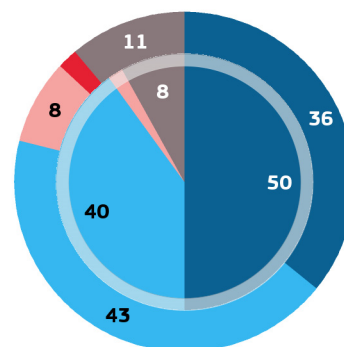

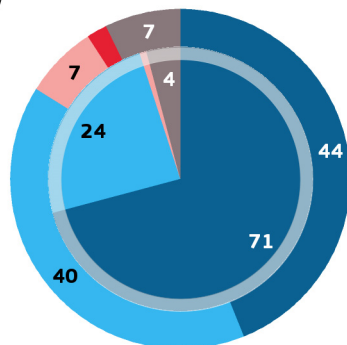

More public financial support should be given to the transition to clean energies even if it means subsidies to fossil fuels should be reduced (%)

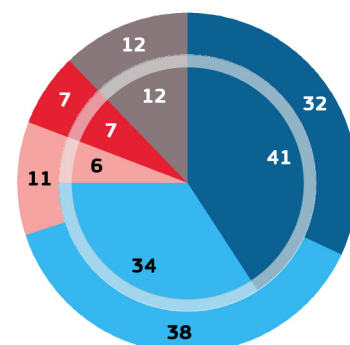

Adapting to the adverse impacts of climate change can have positive outcomes for citizens in the EU (%)

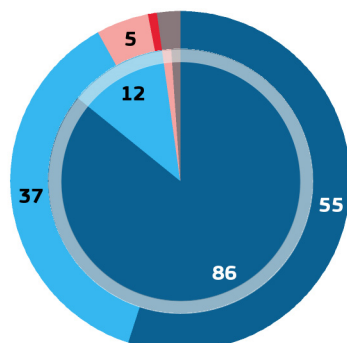

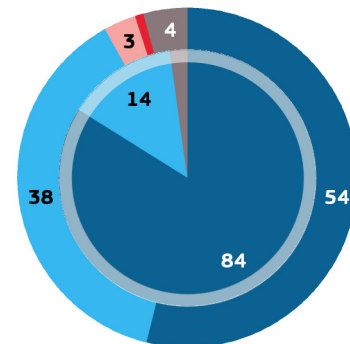
