DECISION OF THE PRESIDENT OF THE EUROPEAN COMMISSION
of 1 December 2024
on the organisation of responsibilities of the Members of the Commission

THE PRESIDENT OF THE EUROPEAN COMMISSION,

Having regard to the Treaty on European Union,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to the Treaty establishing the European Atomic Energy Community,

Having regard to the Commission's Rules of Procedure,

HAS DECIDED AS FOLLOWS:

Article 1
