**establishing the list of proposals selected for funding and the proposals placed on the reserve list under the instrument on supporting ammunition production (ASAP) established by Regulation (EU) 2023/1525 following the 2023 calls for proposals launched under the ASAP work programme for 2023-2025 adopted by the Decision C(2023)7320**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2023/1525 of the European Parliament and of the Council of 20 July 2023 on supporting ammunition production (ASAP)<sup>1</sup>, and in particular Article 11 thereof,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012 ('the Financial Regulation')<sup>2</sup>, and in particular Article 200 thereof,

Whereas:

- (1) Commission Implementing Decision C(2023)7320 of 18 October 2023 on the financing of the instrument on supporting ammunition production (ASAP) established by Regulation (EU) 2023/1525 of the European Parliament and the Council, as amended by Commission Implementing Decision C(2024)2309, adopts the ASAP work programme for 2023-2025.
- (2) The Commission launched the calls for proposals EDF-ASAP-2023-LS-MIS, EDF-ASAP-2023-LS-POW, EDF-ASAP-2023-LS-SHL, EDF-ASAP-2023-LS-TRC and EDF-ASAP-2023-LS-XPL on 18 October 2023.
- (3) The description of the calls is provided in Annex 1.
- (4) These calls for proposals were closed on 13 December 2023. 82 proposals were submitted in response to these calls.
- (5) The evaluation of the proposals was carried out in accordance with the provisions of Article 200 of the Financial Regulation and Article 11 of Regulation (EU) 2023/1525.
- (6) Based on the admissibility, exclusion, eligibility, selection and award criteria laid down in the annual work programme and published in the calls for proposals, 31 proposals have been selected to receive financial support under the ASAP. Another 11 proposals have been placed on a reserve list.

- (7) This Decision concerns proposals which – under Article 11 of Regulation (EU) 2023/1525 – require a Commission award decision in *mode décisionnel*.
- (8) The measures provided for in this Decision are in accordance with the opinion of the ASAP Programme Committee

HAS DECIDED AS FOLLOWS:

*Article 1*

The 31 proposals listed in Annex 2 are awarded a grant under all 2023 ASAP calls for a total maximum grant amount of EUR 512,823,595.56. The 11 proposals listed in Annex 3 are placed on a reserve list.

The list of awarded proposals mentions the corresponding call and, where applicable, the topic, the proposal's coordinator and its country of establishment, the estimated total eligible costs of the action and the maximum amount awarded.

*Article 2*

Proposals listed in Annex 3 (reserve list) successfully complied with the exclusion, eligibility, selection and award criteria laid down in the calls text but are considered rejected for lack of budgetary appropriations.

Proposals in the reserve list may be selected for grants in case budgetary appropriations become available.

Moreover, where the proposals selected for funding fail the grant preparation phase, proposals from the reserve list under the same call may be selected for funding, in the strict order of their ranking.

In case the available budget appropriations are not sufficient to finance the grant of the next ranked proposal under the relevant call, the available amount will be transferred to another call to fund proposals in the order of their ranking and in compliance with the budgetary provisions foreseen in the call conditions.

The reserve list will no longer be valid after the signature of all the grant agreements in relation to the 2023 ASAP calls.
