



E-Cycle Wisconsin Manufacturer Recycling Target Formula and Registration Fee Changes

Beginning with the 2024 program year, annual manufacturer recycling target calculations under E-Cycle Wisconsin will change. Instead of using 80% of the weight of covered electronics manufacturers sold in Wisconsin during a previous year, the targets will be based on a manufacturer’s market share percentage of the total weight of electronics received for recycling under E-Cycle Wisconsin during a previous program year.

The Department of Natural Resources has created this document to help E-Cycle Wisconsin program participants understand and comply with the changes. Please refer to [s. 287.17, Wis. Recycling targets for 2024

- Manufacturer recycling targets for the 2024 program year are based on the weight of covered electronics sold to Wisconsin households and K-12 schools during 2022, which manufacturers reported on their 2024 re-registration and annual report form due March 1, 2024.
- The DNR will calculate each manufacturer’s market share percentage based on the total weight of all covered devices sold in 2022, as reported by registered manufacturers.
- The total recycling target for 2024 is the weight of eligible electronics received for recycling during the July 2021-June 2022 program year, which was 23,356,682 pounds.
- By April 15, 2024, the DNR will provide program year 2024 targets to manufacturers.

Recycling targets for 2025

- By late spring/early summer 2024, manufacturers will need to report to the DNR the weight of covered electronics they sold to Wisconsin households and schools during 2023. The DNR will communicate with manufacturers about how to report this weight.
- The DNR will use this data to calculate each manufacturer’s market share percentage to be used for program year 2025 recycling targets.
- The 2025 total recycling target will be two-thirds of the weight received for recycling during the July 2022-December 2023 transition program year.
- The DNR will provide manufacturers with their 2025 recycling targets by Aug. 1, 2024.

Table 1 summarizes how manufacturer recycling targets are calculated beginning in 2024

Table 2 summarizes the time periods of information manufacturers must provide on their registration and annual report forms beginning with the 2024 program year. The following definitions will help you interpret the table.

“Sales period for registration fee calculation” is defined under s. 287.17 (4) (b) and (be), Wis. Stats., and means the time period used to determine the fee due with the registration submitted by the deadline listed in that row.

“Sales period for recycling target calculation” is defined under s. 287.17 (5) (a) 1, Wis. Stats., and means the sales data submitted to calculate the target for the following program year.

“Report on weight recycled during period” is defined under s. 287.17 (5) (b), Wis. Stats., and means that on the registration and report form due by the deadline in the 2nd column of the row, the manufacturer must report the weight it recycled during this period (the previous program year).

** Manufacturers must submit 2022 sales data to calculate recycling targets for 2024, and 2023 sales data to calculate targets for 2025.

Manufacturer registration fee amounts

Under s. 287.17 (4) (be), Wis. Stats., the registration fees for the program year following the 18-month transition year (registration for the 2024 program year) are as follows:

- Fewer than 375 covered electronic devices sold to Wisconsin households and schools: \$0
- 375 to 749 covered electronic devices sold to Wisconsin households and schools: \$1,875
- 750 or more covered electronic devices sold to Wisconsin households and schools: \$7,500

Effective for the 2025 program year, the manufacturer registration fee categories, as defined by s. 287.17 (4) (b), Wis. Stats., are:

- Fewer than 250 covered electronic devices sold to Wisconsin households and schools: \$0
- 250 to 549 covered electronic devices sold to Wisconsin households and schools: \$2,500
- 550 or more covered electronic devices sold to Wisconsin households and schools: \$5,500
