THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012¹, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2021/690 of the European Parliament and of the Council establishing a Programme for the internal market, competitiveness of enterprises, including small and medium-sized enterprises, the area of plants, food and feed, and European statistics (Single Market Programme) and repealing Regulations (EU) No 99/2013, (EU) No 1287/2013, (EU) No 254/2014 and (EU) No 652/2014.

Having regard to Regulation (EC) No 223/2009 of the European Parliament and of the Council of 11 March 2009 on European statistics², and in particular Article 17 thereof,

Whereas:

- (1) In order to ensure the implementation and development of the Single Market Programme under Regulation (EU) 2021/690 of the European Parliament and of the Council, Implementing Decision C(2023) 8926 was adopted for the years 2024-2027.
- (2) The Annexes to Decision C(2023) 8926 need to be amended in order to include minor editorial precisions as requested by the contributing services, to clarify or delete a particular action or/and integrate a new action in an annex of the decision and to update the financial statement and figures in the documents accordingly.

The amendment regards the implementation of certain actions under the activities "Operation and development of the internal market of goods and services" (budget line 03.020101), "Taxud regulatory work support" (budget line 03.020103), "Company Law" (budget line 03.020104), "Market surveillance" (budget line 03.020107), "Improving the competitiveness of enterprises, particularly SMEs, and supporting their access to markets" (budget line 03.0202) and "Producing and disseminating high quality statistics on Europe" (budget line 03.0205).

(3) Decision C(2023)8926 should therefore be amended accordingly.
