
Annual inflation down to 5.2% in the euro area

Down to 5.9% in the EU

The **euro area** annual inflation rate was 5.2% in August 2023, down from 5.3% in July. A year earlier, the rate was 9.1%. **European Union** annual inflation was 5.9% in August 2023, down from 6.1% in July. A year earlier, the rate was 10.1%. These figures are published by **Eurostat, the statistical office of the European Union**.

The lowest annual rates were registered in **Denmark** (2.3%), **Spain** and **Belgium** (both 2.4%). The highest annual rates were recorded in **Hungary** (14.2%), **Czechia** (10.1%) and **Slovakia** (9.6%). Compared with July, annual inflation fell in fifteen Member States, remained stable in one and rose in eleven.


In August, the highest contribution to the annual **euro area** inflation rate came from services (+2.41 percentage points, pp), followed by food, alcohol & tobacco (+1.98 pp), non-energy industrial goods (+1.19 pp) and energy (-0.34 pp).

Geographical information

The **euro area** consists of Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** includes Belgium, Bulgaria, Czechia, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland and Sweden.

The euro area and European Union data refer to the respective country compositions at a specific point in time. Changes in the composition of these aggregates are incorporated using a chain index formula.

Methods and definitions

Annual inflation is the change of the price level of consumer goods and services between the current month and the same month of the previous year. **Monthly inflation** is the change of the price level between the current month and the previous month.

A **contribution** shows how much of the annual inflation rate comes from a particular component of the HICP. The contributions are calculated according to a method which ensures their additivity (allowing for rounding).

Revisions and timetable

A flash estimate of euro area inflation is issued at the end of each reference month. The euro area flash estimate for August 2023, published on 31 August 2023, was 5.3%.

The next flash estimate of euro area inflation with data for September 2023 is scheduled for 29 September 2023.
