

# DG NEAR FRAMEWORK PARTNERSHIP AGREEMENTS



## for Capacity Development of Civil Society Organisations in the Eastern Partnership

In December 2019, European Commission's Directorate-General for Neighbourhood and Enlargement Negotiations (DG NEAR) signed **Framework Partnership Agreements (FPAs)** with **seven selected civil society organisations** with recognised knowledge, local political awareness and experience in supporting civil society in the Eastern Partnership (Armenia, Azerbaijan, Belarus, Georgia, Moldova, Ukraine) and Russia.

These FPAs will help strengthen the role of civil society organisations as governance actors, contributing to increased outreach and financial support to new civic actors and to grass-root communities. They are an important element of DG NEAR's new strategic approach to supporting civil society in the Eastern Partnership in close cooperation with key partner organisations.
