STABILIZĀCIJAS UN ASOCIĀCIJAS PADOME,

ņemot vērā Stabilizācijas un asociācijas nolīgumu starp Eiropas Kopienām un to dalībvalstīm, no vienas puses, un bijušo Dienvidslāvijas Maķedonijas Republiku, no otras puses ⁽¹⁾ ("nolīgums"), un jo īpaši tā 5. panta 3. punktu,

tā kā:

- (1) Nolīguma 5. panta 1. punktā ir paredzēts maksimāli desmit gadus ilgs pārejas laiks, kas iedalīts divos secīgos posmos.
- (2) Pirmais posms sākās 2004. gada 1. aprīlī, dienā, kad spēkā stājās nolīgums.
- (3) Nolīguma 5. panta 3. punktā ir arī paredzēts, ka Stabilizācijas un asociācijas padomei jāizvērtē gūtie panākumi un jālemj par pāriešanu uz otro posmu un tā ilgumu, kā arī par visām iespējamajām izmaiņām, kas jāizdara attiecībā uz to noteikumu saturu, kas regulē otro posmu.
- (4) Puses apņemas ievērot saistības, kuras saistītas ar pāreju uz asociācijas otro posmu.
- (5) Bijusī Dienvidslāvijas Maķedonijas Republika ir veikusi vajadzīgos pasākumus, lai nodrošinātu visu to saistību ievērošanu, kuras rodas, pārejot uz otro posmu,

1. pants
