## EURAXESS Brazil & LAC Funding opportunities

Dear readers,

["EURAXESS – Researchers in Motion"](#) is a European Commission initiative focused on **researcher mobility and career development**.

Among other activities, **EURAXESS supports individual researchers in finding jobs or funding opportunities** to make their research stay in Europe a reality.

On the [EURAXESS Portal](#), we encourage you to consult the:

- [EURAXESS Job database](#) that lists thousands of vacancies from more than 40 European countries and other regions of the world.
- And the [Funding database](#) allowing you to search for the funding programme you need for your mobility or research cooperation project.

Please note that **individual researchers from Brazil and other LAC countries** can upload their CVs on the portal, register their searches and create alerts to be informed when a vacancy matching their profile has been published.

**Funding organisations**, including from Brazil and other Latin American and Caribbean countries can publish their jobs, funding opportunities and scholarships on the portal to increase their visibility and reach the best candidates worldwide.

To help you identify these opportunities, EURAXESS LAC regularly publishes open calls to fund researchers' mobility and cooperation with European teams. A novelty as from this edition, the list now combines funding opportunities open to both Brazil and other LAC countries. This edition is valid for August and September.

The jobs, grants and fellowships announced are **organised by funding organisations (including private ones)**. In section 1, you'll find calls **funded by the European Commission**, in section 2, calls launched by **individual EU member states or associated countries**, and in section 3, calls **promoted by LAC institutions** open to researchers from Latin America and the Caribbean. In section 4, you'll find all the calls that were listed in previous editions of this document and that are **still open**.

We remain at your disposal to discuss any queries you may have regarding your mobility projects.

### 1.3 [ERC Advanced Grants](#) (5 years research projects in Europe, all areas)

ERC Advanced Grants are long-term funding to pursue ground-breaking high-risk projects. They are designed to support excellent Principal Investigators at the career stage at which they are already established research leaders with a recognised track record of research achievements. This action is open to researchers of any nationality who intend to conduct their research activity in any European Member State or Associated Country.

The ERC's frontier research grants operate on a 'bottom-up' basis without predetermined priorities.

**Eligibility:** any nationality, any age. Applicants must be leaders in their respective field(s) of research and must demonstrate significant achievement in the last 10 years

**Funding:** up to € 2.5 million per grant (up to € 3.5 million in some cases)

**Duration:** up to 5 years

**Sole evaluation criterion:** scientific excellence of researcher and research proposal

**Deadline:** 30 August 2018. For more details on Advanced grants, see [ERC website](#)

### 1.4 European University institute (EUI, Italy) – incoming fellowships in social sciences and humanities

#### 1.4.1 [Fernand Braudel Senior Fellowship](#)

Fellowships last for up to ten months in one of the EUI's four Departments which in turn invite fellows to participate in departmental activities (seminars, workshops, colloquia, etc.).

Fellows are encouraged to make contact with researchers sharing their academic interests, may be involved in the teaching and thesis supervision tasks of EUI professors, and associated with one of the research projects being carried out at the EUI.

Departments with open calls for the current call:

- Department of Economics
- Department of History and Civilization

**Deadline:** 30 September 2018

#### 1.4.2 [Max Weber Fellowships for junior post-docs](#)

Max Weber fellowships are designed for junior post-docs who would like to pursue an academic career, concentrate on their own research and enhance their academic practice in a multidisciplinary environment. The Programme awards 1, 2, and exceptionally 3 year-long fellowships in the fields of political and social sciences, economics, law and history.

### 1.1 [Horizon 2020 – Work programme 2018-2020](#) and [List of calls particularly interesting for Brazil](#) and [LAC countries!](#)

The European Union's Horizon 2020 Work Programme 2018-2020, including preliminary information on all calls to be launched until 2020 has now been published.

[Horizon 2020](#) is the EU funding programme for research and innovation running from 2014 to 2020 with a €80 billion budget. **H2020** supports scientifically-excellent research, innovation, and technological development, through [collaborative and innovative research projects as well as grants and fellowships to individuals](#) set out in the Horizon 2020 work programme. The vast majority of this funding is allocated on the basis of **competitive calls open to applications from researchers, businesses and other interested organisations** located in any of the EU Member States or countries [associated](#) to Horizon 2020.

It is open to the world, so **Brazilian and LAC researchers** and institutions are very welcome to get involved.

The final Work Programme for Horizon 2020 covers the budgetary years 2018, 2019 and 2020, representing an investment of around €30 billion.

Access all open calls on the [Horizon 2020 Participant Portal](#) by entering the Topic ID of the call in the search engine (top-right corner of page).

**Organisations from any sector and country, including LAC countries** can participate in H2020 projects.

**Only organisations from the Bahamas, Barbados, Brazil, Mexico and Trinidad and Tobago** are not eligible for direct funding by the European Commission, unless clearly stated. It is suggested that Brazilian and Mexican organisations check their local co-funding schemes to support their participation ([here](#) for Brazil, and [here](#) for Mexico).

**Please, note that all Latin American and Caribbean individual researchers** are eligible to funding by MSCA and ERC.



**Brazil and ERC:**

To date, **seven Brazilian researchers have been awarded ERC Starting and Consolidator Grants**. They are (picture left to right - Click on the blue names to read their interviews): The Fields medallist [Artur Avila](#) for his Quasiperiodic project; [Aureo de Paula](#) for his project on “Econometric Analysis of Interaction Models”; [Elison Matioli](#) for his project IN-NEED on energy efficiency; [Bernardo Franklin](#) for his Plat-IL-1 project on inflammasomes; [Eduardo Lee](#) for his project TOPOQDot on topological materials; [Roberto Rinaldi](#) for his LIGNINFIRST project on lignocellulosic Biomass; [Mariana de Campos Franço](#) for her BRASILIAE project on Indigenous knowledge.

One of the **2018 Fields Medals**, awarded to **outstanding mathematicians**, was given to a grantee of the European Research Council (ERC): **Prof. Alessio Figalli (Italy)**, an ERC Consolidator grant holder since 2016 at ETH Zürich, Switzerland. More on this [here](#).

**1.2 [ERC Starting Grants – call to be launched in September](#)**

European Research Council’s (ERC) Starting Grants are designed to support excellent Principal Investigators at the career stage at which they are **starting their own independent research team or programme in all scientific fields**.

**ERC Starting Grants in brief:**

- For researchers of **any nationality** with **2-7 years of experience** since completion of PhD (or equivalent degree) and scientific track record showing great promise
- **Research must be conducted in a public or private research organisation** located in one of the EU [Member States](#) or [Associated Countries](#) (including Switzerland)
- Funding per grant: **up to € 1.5 million**. An additional € 0.5 million can be made available to cover eligible “start-up” costs for researchers moving from a third country to the EU or to an associated country and/or the purchase of major equipment and/or access to large facilities.
- Duration: **up to 5 years**
- Sole evaluation criterion: scientific excellence of researcher and research proposal
- Calls for proposals: published once a year

**ERC open to the world**

The ERC strives to attract top researchers from anywhere in the world to come to Europe. To date, the ERC has funded some 7 000 top researchers at various stages of their careers.

Currently, there are **621 principal investigators of non-ERA nationality**, representing 8% of all grantees. These grant holders are mainly nationals of the US (212), Canada (61), Russia (40), Australia (35), India (35), and Japan (24).

Please, note that ERC grants support projects carried out by an individual researcher (“Principal Investigator”) who can **employ researchers of any nationality as team members**. It is also possible to have one or more team members located in a non-European country. Vacancies for team members interested in joining an ERC led research project, can be published on the [Euraxess-Jobs portal](#).

Expected deadline: **17 October 2018**

**1.3 [ERC Synergy Grants – call to be launched in September](#)**

WHAT? European Research Council ERC Synergy Grants are designed to tackle truly bold scientific challenges by funding **groups of up to 4 excellent PIs** who jointly address the frontier of knowledge.

WHO? This action is open to **researchers of any nationality** with early achievement or a 10-year track-record who intend to conduct their research activity in any Member State or Associated Country.

Please, note that as from July 2018, Synergy Grant Group can include up to one Principal Investigator based in a third country, including in Brazil and other LAC countries.



## Participation of team members from LAC countries:

ERC grants support projects carried out by an individual researcher ('Principal Investigator') in the case of Starting Grants, or 2 to 4 individual researchers (under Synergy Grants) who can employ researchers of any nationality as team members. It is also possible to have one or more team members located in a non-European country. Vacancies for team members of an ERC project can be published on the [EURAXESS Jobs portal](#).

## Implementing arrangements in practice:

ERC launches an annual Call for expression of interest amongst ERC grantees to inquire about their interest to host scientists from those 3 LAC countries in their research teams. The list is then sent to the Latin American institutions who inform their scientists about the opportunities. The pre-selection of the scientists is done by the LAC funding agencies, without any ERC intervention (neither in the selection criteria nor in the selection procedure).

The ERC's frontier research grants operate on a 'bottom-up' basis without predetermined priorities.

### ERC Synergy Grants in brief:

- Fund a small group of PIs (2 to 4) with a designated corresponding PI who applies.
- Research projects must tackle ambitious scientific challenges through a unique combination of skills and knowledge of the PIs. Applications must demonstrate that the proposed research cannot be carried out by a single PI working alone.
- Any field of research.
- For researchers of **any nationality** presenting an early achievement track-record or a ten-year track-record
- **Research must be conducted** by all PIs in **public or private research organisation(s)** located in one of the EU [Member States](#) or [Associated Countries](#) (including Switzerland). One PI can be based outside of EU or AC. PIs can apply within the same host institution (HI) or through different HIs.
- Each of the PIs shall spend a minimum of 50% of their total working time in an EU Member State or Associated Country (except the one located out of Europe, if any), and a minimum of 30% of their total working time on the ERC project.
- Funding per grant: **up to EUR 10 million** (in some circumstances up to EUR 14 million)
- Duration: **up to 6 years**
- Sole evaluation criterion: scientific excellence of the proposal
- Calls for proposals: published once a year

Expected deadline: **8 November 2018**

## 1.4 Post doctoral visits to ERC teams in Europe (Brazil & Mexico) – calls open

**Scientists from Argentina, Brazil and Mexico can temporarily join ERC-funded teams in Europe** thanks to the **Implementing Arrangements (IAs)** signed between local funding agencies and the European Commission.

Research visits can be either one-offs and long-term (6-12 months), or multiple short-term visits (for Argentinian and Brazilian researchers).

Brazil and Mexico are currently receiving applications for the selection of :

- Brazilian post-doctoral grantees from FAPs, CAPES and CNPq;
- Mexican National Council of Science and Technology (CONACYT) Research and Postdoctoral Fellows.

No call is currently open for Argentina.

## 1.5 European Molecular Biology Laboratory (EMBL) Incoming Calls

### 1.5.1 [International PhD programme](#)

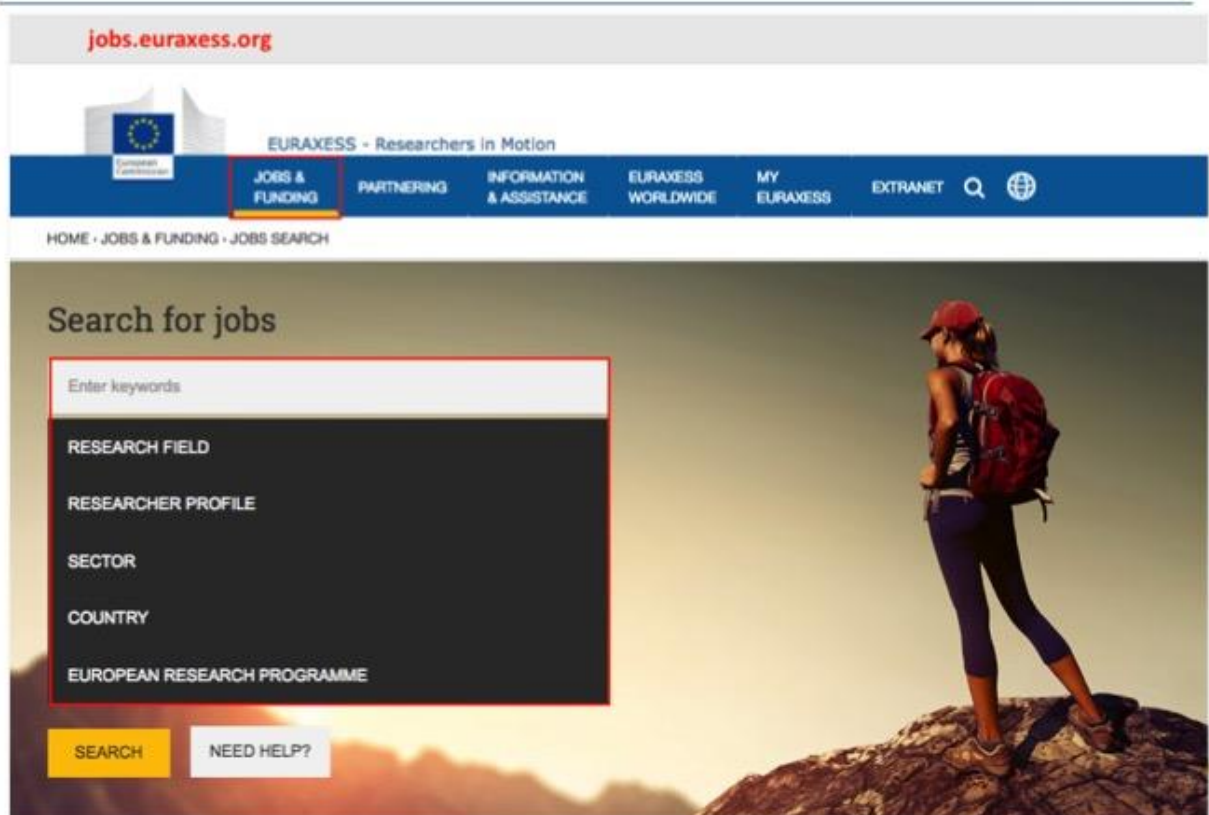

- May not have resided or carried out their main activity (work, studies, etc.) in Denmark for more than 12 months in the 3 years immediately prior to TALENT's call deadline: October 1, 2018. Time spent on obtaining refugee status under the Geneva Convention, compulsory national service and/or short stays such as holidays are not taken into account.

## 2.10 GERMANY (DAAD) [Research Grants – Doctoral Programmes open to Argentina, Chile, Colombia, Mexico and many more LAC countries](#) (incoming)

DAAD research grants provide young foreign academics and scientists (including LAC countries like Argentina, Chile, Colombia, Mexico and many more) with an opportunity to carry out research and continue their education in Germany. The grants also promote the exchange of experience and networking amongst colleagues.

The aim of this grant programme is to support doctoral projects in Germany.

**Eligibility:** Excellently-qualified young academics and scientists who have completed a **Master's degree or Diploma**, or in exceptional cases a Bachelor's degree at the latest by the time they begin their grant-supported research.

Doctoral programmes at a state or state-recognised institution of higher education or a non-university research institute in Germany:

- individual projects under the supervision of a university teacher or academic adviser, or
- participation in a structured doctoral study programme

**Duration:** a maximum of **four years**;

Grants are initially awarded for a maximum of one year. Extensions depend on whether the selection committee considers the previous award period to have been successfully completed.

For doctoral projects in Germany that require several years of research, research phases outside Germany can be supported if these are critical for the successful completion of the doctoral degree. Planned stays must be specified in the application in the work and time schedule and should not exceed a quarter of the anticipated total funding period.

## 2.11 GERMANY – DAAD scholarships in Arts and architecture (Incoming)

The FCFP call for applications is co-financed by the European Union through the **Horizon 2020** research and innovation programme “**Marie Skłodowska-Curie Action**, People, Co-funding of regional, national and international programs (**COFUND**)” and the State of Baden-Württemberg. The rules and ethical principles for Horizon 2020 and the state regulations apply.

The Freiburg Institute for Advanced Studies (FRIAS) is offering **Individual FCFP fellowships** for the academic year 2019-20:

- **Junior fellowships** (completed PhD plus one to six years of post-doctoral experience)
- 12 month fellowships between September 1, 2019 and September 30, 2020
- **Senior fellowships** (completed PhD plus a minimum of six years of post-doctoral experience or a tenured professorship or equivalent permanent position)

Junior Fellows must apply for this option eight months into their fellowship.

**Eligibility:** While the disciplinary focus within the research groups should be on the social sciences, interdisciplinary projects are also welcome. This call targets **applicants at all career levels post-Ph.D.** who are employed by a university or research institution.



Funding: The budget may include personnel as well as non-personnel expenses, such as travel costs, consumables, acquisition of data, and equipment.

The main share of the funds provided for staff has to be allocated to junior scholars.

Personnel costs will be covered according to local standards; in general, PhD positions should be budgeted for a minimum of three years and can be budgeted for a duration of up to four years.

Based on a government mandate, the [Swiss National Science Foundation \(SNSF\)](#) supports scientific research in all academic disciplines, from history to medicine and the engineering sciences. At the end of 2017, the SNSF was funding 5800 projects involving 16,000 researchers, which makes it the leading Swiss institution for promoting scientific research.

Ambizione grants are aimed at young researchers who wish to conduct, manage and lead an independent project at a Swiss higher education institution. The scheme supports young researchers **both from Switzerland and abroad**. Scientists holding non-professorial academic positions at higher education institutions are also eligible to submit an application.

An Ambizione grant covers the grantee's salary and the funds needed to carry out the project. An Ambizione project grant, however, comprises only project funds. The grants are awarded **for a maximum of four years**.

Participation requirements include:

- Applicants must hold a Doctorate (PhD) or have completed their medical studies (Staatsexamen or equivalent exam).

## 3 Latin American and the Caribbean

### 3.1 BRAZIL (CNPq) - [grants for incoming and outgoing research mobility](#)

The Brazilian National Council for Scientific and Technological Development ([CNPq](#)) recently released a call to finance outgoing and incoming research mobility with an estimated **60 million BRL budget**. The goal is to support research projects that aim to contribute significantly to the development of science, technology and innovation in Brazil, through the granting of **scholarships** within the country and abroad.

The **outgoing calls** aim to support mobility of Brazilian (or foreign residents in Brazil) trainees, PhD students and postdoctoral researchers to other countries. They have different time frames (from 3 to 48 months) and are divided into 3 different categories: Senior Internship (ESN); Post-Doctorate Abroad (PDE); Sandwich Doctorate Abroad (SWE).

The **incoming calls** are open to attract researchers based abroad for research stays from 3 to 12 months, in various types of mobility, including partnerships with companies. Open calls on 7 different categories: Junior Post-Doctorate (DPJ); Senior Post-Doctorate (PDS); Sandwich Doctorate in the Country (SWP); Business Post-Doctorate (PDI); Business Sandwich Doctorate (SWI), visiting professors (PV).

Deadline for scholarships beginning between September 2019 and February 2020: **8 March 2019**.

### 3.2 BRAZIL (CONFAP & CNPq) - [Call to Brazilian researchers temporarily join a team run by an ERC grantee](#)

The Brazilian National Council of State Funding Agencies – [CONFAP](#) and the National Council for Scientific and Technological Development ([CNPq](#)) launched a call to select researchers from Brazil willing to pursue research **collaborations with Principal Investigators** already supported through EU-funded European Research Council ([ERC](#)) grants.

Scientific exchanges shall start in the **second semester of 2018** and can be either performed on a more extended timeframe (i.e. lasting 6 to 12 months) or be divided in multiple and shorter visits, i.e. to perform joint experimentation or similar research activities.

**WHO:** Active researchers from Brazil, holding a PhD, who are implementing research activities within Brazilian universities, institutes or research centers.

Additional eligibility criteria may be requested by the supporting Funding Agencies, which shall, in such cases, publish specific guidelines.

#### How to apply?

Eligible researchers must access and register at the online portal, available [here](#). They will then be able to access information about the ERC grantees that expressed interest in hosting scientists from Brazil in their research teams. The Brazilian researchers are responsible for agreeing on the details of their research stay with the ERC grantee and then submit their formal proposal on the dedicated portal mentioned above.

Eligible researchers from Brazil will continue to receive their salaries and/or scholarship according to their institutional terms and conditions. The Brazilian State Funding Agencies participating in the present call or CNPq will provide support for travel expenses.



The pre-selection of the scientists is done by the Brazilian funding agencies, without any ERC intervention (neither in the selection criteria nor in the selection procedure).

Deadline : **31 August 2018**

### 3.3 BRAZIL (FAPESP) – [International Call for Proposals to lead independent research groups in partnership with Max Planck Institutes](#)

This call aims to strengthen the collaboration between universities and research institutions in the state of São Paulo, Brazil, and **Max Planck Institutes**, worldwide.

**Young highly qualified researchers**, with **at least two years of very well succeeded postdoctoral experience**, are invited to submit research proposals to establish independent Tandem Research Groups at **universities or research institutes in the state of São Paulo**, Brazil, **in strong collaboration with researchers in one of the 84 Max Planck Institutes**.

For **Mexican researchers linked to CONACYT**.

Every year when this call opens, **(CONACYT) Research and Postdoctoral Fellows can temporarily join ERC funded teams in Europe** thanks to the Implementing Arrangement signed between CONACYT and the European Commission.

**Eligibility:** The call is open to current researchers of CONACYT's National System of Researchers (SNI I, II and III), to develop collaborative research activities with European researchers who are being supported by the European Research Council (ERC).

**Duration:** One-offs (6-12 months research visits). Possibility of starting in the Spring of 2019.

**Funding:** CONACYT will provide complementary support adjustable to the number of months the visit lasts: Up to \$ 45,000 pesos monthly payments that can be used for travel expenses (flights, lodging, food and local transportation in the place of the research visit) and other subsistence related expenses related to their research visit whilst abroad.

In certain cases, the European Principal Investigator may, depending on budgets and the country where the visit will be made, provide additional support to cover certain expenses of the incoming Mexican researcher during their stay.

### 3.6 MEXICO - [Mexican Government Scholarships for International Students, 2018-2019](#)

The Mexican Government is inviting international students to study for a **specialisation, master's degree or doctorate, conducting graduate or postdoctoral research**, or taking part in an undergraduate or graduate -level academic mobility programme.

On 12 November 2015 CONACYT and the European Commission signed an **Implementation Agreement** with the purpose of strengthening the cooperation between Mexico and the European Union through the exchange of Mexican scientists via **research visits** to collaborate on projects with European researchers which are being supported by the European Research Council – ERC. ERC launches an annual Call for expression of interest amongst ERC grantees to inquire about their interest to host scientists from Mexico in their research teams. The list is then sent to CONACYT who informs their scientists about the opportunities. The pre-selection of the scientists is done by CONACYT, without any ERC intervention (neither in the selection criteria nor in the selection procedure).



The scholarships are offered to more than 180 countries through a series of bilateral conventions, multilateral programmes and special agreements. More than 70 Mexican institutions participate and all offer academic programmes registered with the National Council for Science and Technology (CONACYT) as National Quality Graduate Programmes.

## Research fields

Scholarships are provided to study any one of the courses available at participating Mexican institutions except Business administration, Plastic surgery, accounting, marketing, dentistry, Odontology and advertising.
