Did you know?

Individual researchers from Brazil and other LAC countries can upload their CVs on the portal, register their **searches** and **create alerts** to be informed when a vacancy matching their profile has been published.

Funding organisations, including from Brazil and other Latin American and Caribbean countries can publish their jobs, funding opportunities and scholarships on the portal – **for free** - to increase their visibility and reach the best candidates worldwide.

To help you identify these opportunities, EURAXESS LAC regularly publishes open calls to fund researchers' mobility and cooperation with European teams. The list combines funding opportunities open to both Brazil and other LAC countries.

The jobs, grants and fellowships announced are **organised by funding organisations (including private ones)**. In section 1, you'll find calls **funded by the European Commission**, in section 2, calls launched by **individual EU member states or associated countries** with or without LAC partners, and in **section 3, calls promoted by LAC institutions**. All of them are open to researchers from at least some Latin America and the Caribbean countries. In section 4, you'll find all the calls that were listed in previous editions of this document and that are **still open**.

We remain at your disposal to discuss any queries you may have regarding your mobility projects.

ERC grants support projects carried out by an individual researcher ("Principal Investigator") who can employ researchers of any nationality as team members. It is also possible to have one or more team members located in a non-European country.

1.3 [ERC Advanced Grants \(5 years research projects in Europe, all areas\)](#)

ERC Advanced Grants are long-term funding to pursue ground-breaking high-risk projects. They are designed to support excellent Principal Investigators at the career stage at which they are already established research leaders with a recognised track record of research achievements. This action is open to researchers of any nationality who intend to conduct their research activity in any European Member State or Associated Country.

The ERC's frontier research grants operate on a 'bottom-up' basis without predetermined priorities.

Eligibility: any nationality, any age. Applicants must be leaders in their respective field(s) of research and must demonstrate significant achievement in the last 10 years

Funding: up to € 2.5 million per grant (up to € 3.5 million in some cases)

Duration: up to 5 years

Sole evaluation criterion: scientific excellence of researcher and research proposal

Deadline: 30 August 2018. For more details on Advanced grants, see [ERC website](#)

1.4 European University institute (EUI, Italy) – incoming fellowships in social sciences and humanities

1.4.1 [Fernand Braudel Senior Fellowship](#)

Fellowships last for up to ten months in one of the EUI's four Departments which in turn invite fellows to participate in departmental activities (seminars, workshops, colloquia, etc.).

Fellows are encouraged to make contact with researchers sharing their academic interests, may be involved in the teaching and thesis supervision tasks of EUI professors, and associated with one of the research projects being carried out at the EUI.

1.4.2 [Max Weber Fellowships for junior post-docs](#)

Max Weber fellowships are designed for junior post-docs who would like to pursue an academic career, concentrate on their own research and enhance their academic practice in a multidisciplinary environment. The Programme awards 1, 2, and exceptionally 3 year long fellowships in the fields of political and social sciences, economics, law and history.

[Horizon 2020](#) is the EU funding programme for research and innovation running from 2014 to 2020 with a €80 billion budget. **H2020** supports scientifically-excellent research, innovation, and technological development, through [collaborative and innovative research projects as well as grants and fellowships to individuals](#) set out in the Horizon 2020 work programme. The vast majority of this funding is allocated on the basis of **competitive calls open to applications from researchers, businesses and other interested organisations** located in any of the EU Member States or countries [associated](#) to Horizon 2020.

It is open to the world, so **Brazilian and LAC researchers** and institutions are very welcome to get involved.

The final Work Programme for Horizon 2020 covers the budgetary years 2018, 2019 and 2020, representing an investment of around €30 billion.

Access all open calls on the [Horizon 2020 Funding & tender opportunities Portal](#). One can filter by keyword, programme part, focus area, cross-cutting priority.

Organisations from any sector and country, including LAC countries can participate in H2020 projects.

Only organisations from the Bahamas, Barbados, Brazil, Mexico and Trinidad and Tobago are not eligible for direct automatic funding by the European Commission, unless clearly stated in the call. It is suggested that Brazilian and Mexican organisations check their local co-funding schemes to support their participation ([here](#) for Brazil, and [here](#) for Mexico).

Please, note that all Latin American and Caribbean individual researchers are eligible to funding by MSCA and ERC.



1.2 [European Innovation Council \(EIC\) prizes](#)



The [EIC](#) pilot aims to support top-class innovators, entrepreneurs, small companies and researchers with bright ideas and the ambition to scale-up internationally.

Each EIC Horizon Prize has an ambitious goal to solve a major challenge facing society, without detailing how this should be achieved or who should achieve it. These prizes are **open to anyone willing to think outside the box across sectors and disciplines**. The prize is awarded to whoever best meets the challenge.

1.2.1 [Affordable High-Tech for Humanitarian Aid](#)

The challenge is to develop innovative and more cost-effective solutions to be used in a humanitarian aid context, based on frugal application of advanced technologies. **Prize value: €5 million. Deadline: first quarter of 2020.**

1.2.2 [Fuel from the Sun: Artificial Photosynthesis](#)

The challenge is to build a functional prototype of an artificial photosynthesis-based system which is able to produce a useable synthetic fuel. **Prize value: €5 million. Deadline: first quarter of 2021.**

1.2.3 [Early Warning for Epidemics](#)

The challenge is to develop a scalable, reliable and cost-effective early warning system to forecast, monitor and ultimately prevent outbreaks of one or more vector-borne diseases. **Prize value: €5 million. Deadline: 1 September 2020.**

1.4 Selection of institutions willing to host Post-doc MSCA Individual Fellows (MSCA IF)

The [Marie Skłodowska-Curie Individual Fellowships \(MSCA-IF\) call](#) is open until **11 September 2019**. It allows successful candidates to work on a research project and enjoy advanced training for up to 24 months. The programme provides a competitive salary, mobility and family allowance plus a budget for research and training costs.

To apply for the fellowship, Latin American and the Caribbean-based researchers have to secure the [approval of a research organisation in Europe](#) that is willing to host him or her for the duration of the MSCA IF fellowship. The host institution can be public or private, from the academy or not.

We selected some hosting offers below, but remember to regularly **check EURAXESS portal with hosting offers** as well.

1.4.1 AUSTRIA – [University of Applied Sciences Upper Austria](#)

University of Applied Sciences Upper Austria / School of Informatics, Communications and Media cordially welcomes Expressions of Interest (Eoi) from researchers to apply to the MSCA Individual Fellowship scheme. **Applications will be supported by a host supervisor.**

The time in the university will include an individual research project combined with advanced training, ranging from presentation skills and project management to proposal writing (including for ERC Starting Grants), and two-way knowledge transfer both in the research area and in transferable skills.

Main research areas at the University of Applied Sciences Upper Austria's School of Informatics, Communications and Media are



MSCA-IF aims at supporting the international mobility of researchers to and within (European Fellowships) and beyond Europe (Global Fellowships) as well as helping to attract the best foreign researchers to work in the EU. **The grant usually covers two years' salary, a mobility allowance, research costs and overheads for the host institution.**

1.6 ERCIM – [Alain Bensoussan Fellowships \(incoming\)](#)

ERCIM, the European Research Consortium for Informatics and Mathematics, offers fellowships for **PhD holders from all over the world**. Fellowships are of a 12 months duration, spent in [one of the leading European Research Institutes which makes up part of the ERCIM network](#).

Researchers must have obtained a PhD degree during the last 8 years (prior to the application year deadline) or be in the last year of the thesis work with an outstanding academic record. Nevertheless, before starting the grant, a proof of the PhD degree will be requested. Not only researchers from academic institutions can apply, but also scientists working in industry.

By 2040, the number of Europeans suffering from early and late stage Age-Related Macular Degeneration (AMD) will have increased to over 26 million. 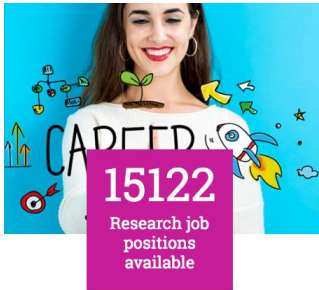

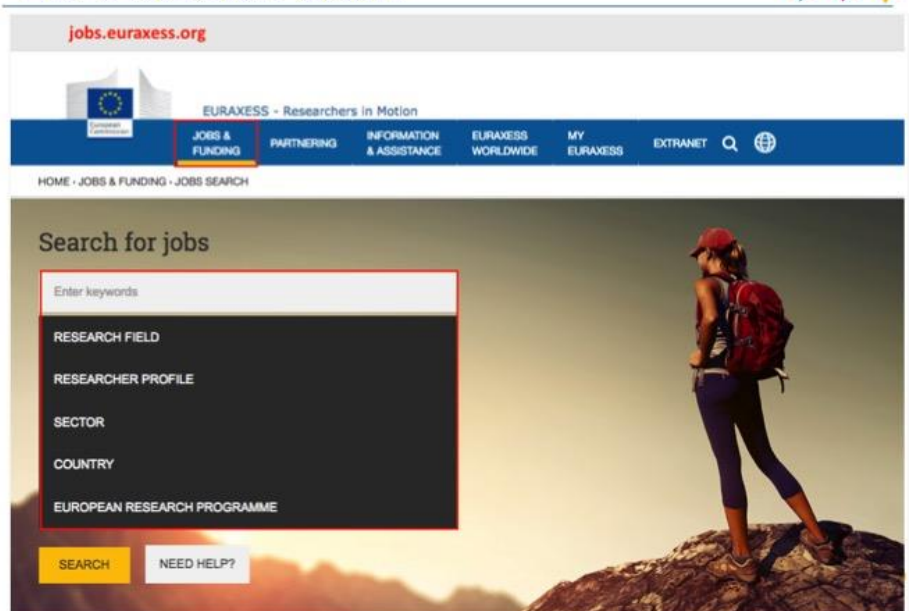

FinCEAL Plus BRIDGES is a project financed by the Finnish Ministry of Education and Culture in 2019-2020 with the purpose of **supporting collaboration between the Finnish research community and their counterparts in Africa, Asia and the LAC regions**.

Through the Partnership Support Instrument, **researchers based in Finnish institutions** can apply for one of the following funding modalities:

3. Research Visit Grants.

to invite partner researchers from the target regions for short-term visits. The invited expert should be either a senior researcher (already has a PhD) or a senior staff member. The joint research activity should be relevant to one or more of the SDG's.

Applications can be sent in at any time, but applicants are advised to apply for funding at least 2 months before their planned activity. All funded activities must take place between 1 April and 31 December 2019.

2.6 FRANCE (Outgoing) - [French-Brazilian Chairs in the Federal University of Uberlândia](#)

The Federal University Uberlândia (UFU) and the French Embassy launched a call for applications for 2 French Chairs. The call is open to professors or researchers from French higher education and research institutions in all research areas. The chairs must be co-directed by a Brazilian professor.

JEA objective is not to fund individual grants, nor to support already achieved teams. It aims to reinforce the experiences of researchers from developing countries in a research and capacity-building programme, in order that JEAs become world-class centres of excellence in their field and get integrated in national, regional or international networks.

The « Jeunes Équipes Associées à l'IRD » (JEA) programme is designed to promote and strengthen new research teams in developing countries **including Latin America and Caribbean countries (LAC)** through partnerships with IRD (Institut de Recherche pour le Développement) research units.

This programme promotes the **set up and/or the strengthening of research teams in developing countries.**

The 'new team' (Jeune Equipe) concept is to be understood from the point of view of its date of creation. There is **no absolute link with the age** of the team members. It is however strongly recommended that these teams include a significant amount of **early career researchers.**

Joint research and capacity-building activities with the partner research unit lead to build a collective scientific dynamic, the goal of which is to guarantee a long lasting research team.

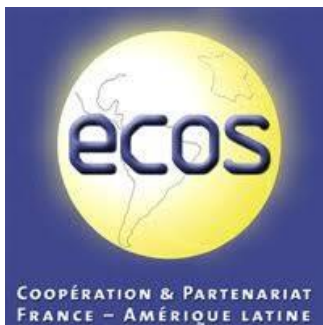

2.8 FRANCE (French Government) – ARGENTINA (MECCyT) – [ECOS call for projects](#)



Institutional partners in France: Ministry of Europe and Foreign Affairs and Ministry of Higher Education, Research and Innovation.

Institutional partners in **Argentina**: Ministerio de Educación, Cultura, Ciencia y Tecnología de la República Argentina **MECCyT.**

Based on partnership and transparency, the ECOS programme is designed to support projects of excellence in scientific collaboration. It funds exchanges between researchers in the form of **short-term assignments and specialisations for doctoral and postdoctoral students** participating in the selected projects.

Collaborations on a joint scientific project with a Argentinian partner are currently being selected. Doctoral training has to be included in the collaboration.

Three-year projects will be selected in the following areas:

- Health and society: infectious, emerging, rare diseases.
- Nanosciences and nanotechnology, science and information technology
- Migrations, urbanization, and social inequality
- Agro-economy and sustainable food.

The **Argentinian** partner must submit his project simultaneously to MINCyT.

2.9 GERMANY (DAAD) – [Development-Related Postgraduate Courses \(EPOS\)](#)

The EPOS programme offers **individual scholarships to participants from developing countries** so that they may study development-related **postgraduate courses** at selected universities in Germany.

The scholarships offer **foreign graduates** from **all disciplines** and with at least two years' professional experience the chance to take a **postgraduate or Master's degree at a state or state-recognised German university**, and in exceptional cases to take a doctoral degree, and to obtain a university qualification (Master's/PhD) in Germany.

What is supported?

Individual scholarships exclusively for Postgraduate courses in Germany that are listed on the ["List of all Postgraduate courses with application deadlines"](#) that include

- Depending on academic level, monthly payments of 850 euros for graduates or 1,000 euros for doctoral candidates
- Payments towards health, accident and personal liability insurance cover
- Travel allowance, unless these expenses are covered by the home country or another source of funding

2.10 GERMANY - [Postdoctoral Researchers International Mobility Experience \(P.R.I.M.E.\)](#)

Postdoctoral researchers of **all nationalities**, who see their long-term career perspectives in Germany, will be given the opportunity to combine employment at a German university with a research stay abroad.

Funding is provided through an 18-month temporary job position at the selected German University, in which 12 months have to be spent abroad and 6 months (re-integration phase) at a German university. The re-integration phase is mandatory. The German university administrates the salary during the whole funding period

Applications may be submitted before completion of the PhD. However, the PhD must be completed before the start of the funding period.

2.25.1 SCAS [General Fellowship Programme](#)

The Collegium is a scholarly community where Fellows pursue research of their own choosing in a context of interdisciplinary dialogue and cooperation. The ambition is to provide an optimal research environment. SCAS hosts senior scholars from all over the world as well as early-career scholars, mainly from the Pro Futura Scientia Programme, most of them nominated by Swedish universities but many with a scholarly background from other countries.

The Swedish Collegium for Advanced Study (SCAS) offers a General Residential Fellowship Programme **open to scholars from all countries**. The programme gives fellows the opportunity to concentrate on their own research interests, free from the teaching and administrative obligations of ordinary university life. Fellows are, however, expected to be active members of the scholarly community of the Collegium and to participate in seminars and academic events beyond their own fields of specialization.

WHO? At the time of application, the **candidate must have held a PhD (or equivalent degree) for at least three years**. Early career scholars must have a promising track record of independent achievements beyond the post-doctoral level, including significant publications, and be active in international fora.

Senior candidates (those who have held a PhD for at least ten years) must have demonstrated a track record of significant and original research achievements over a sequence of years and be active at the international forefront of their research fields.

Scholars may apply for a **full academic year or one semester**.

Seed Money Grants are meant to pay project related costs, travels, organization of workshops, conferences, consumables, accommodations, fieldwork, but are not designed to pay salaries, tuition fees, outsourced services and hardware.

Eligibility: The call is open for activities in **all scientific disciplines** and fields for mono- or interdisciplinary research projects.

A Swiss Principal Investigator/Researcher holding a position in an eligible Swiss Institution must act as the main applicant and is qualified to submit the proposal.

Applications that include Master and PhD students must be submitted by their supervisors. Researchers of federal and cantonal universities, universities of applied sciences and universities of teachers' education, as well as public research institutions are entitled to apply.

The Principal Investigator/Researcher in Latin America must be affiliated to an accredited university or a public research institute and must hold a faculty or scientist position or a doctoral degree besides bringing along several years of research experience.

In addition to the Latin American and the Swiss Investigators/Researchers, other collaborating partners, including researchers affiliated to international organizations and think tanks may also qualify to participate if they have a solid track record of research and publications.

Researcher Links provides researchers with travel grants and funding for workshops. The British Council runs in Brazil Researcher Links in partnership with Confap and FAPESP. Researcher Links workshop grants provide **financial support to organise workshops for early career researchers**.

These workshops are coordinated by recognised senior researchers in their field of activities. The two coordinators (one British and one Brazilian researcher) will be able to identify four other leading researchers, two from each country, to participate as mentors, and the other participants should be early-stage researchers from both countries (between 12 and 17 from each country). The workshops should be in English and last 3 to 5 days.
