This Regulation will lay down rules concerning germinal products of bovine, porcine, ovine, caprine and equine animals.

Those rules cover:

- a) the information to be provided by operators in applications for approval of germinal product establishments and the time-limits for providing such information, as well as the time-limits for informing the competent authority of any cessation of activity of such germinal product establishments approved by it;
- b) the technical requirements and specifications for the marking of those germinal products and the operational requirements for their traceability.
