The essential elements for the rules on the identification and registration of certain kept terrestrial animals are contained in Part IV of Regulation (EU) 2016/429 and complementary details are laid down in Delegated Regulation (EU) 2019/2035. This Implementing Regulation will provide for technical details for the uniform application of these rules and for the technical specifications of central databases of animal registers, the time limits for recording animal movements in central databases, the technical and operational rules for the means and methods of identification and the practical application of exemptions from identification and registration requirements.
