- B.02** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision amending Implementing Decision (EU) 2016/2008 concerning animal health control measures relating to lumpy skin disease in certain Member States and Implementing Decision (EU) 2016/2009 approving the vaccination programmes against lumpy skin disease submitted by the Member States. The aim of this act is to remove the entire territory of Croatia from the list of areas "free with vaccination" regarding Lumpy Skin Disease and the list of countries with an approved Lumpy Skin Disease vaccination, since vaccination against the disease is not practiced in Croatia since the beginning of 2018 and the results of surveillance ever since demonstrate disease absence.
