



## Managing long-term liability for geologic storage of CO<sub>2</sub> Joint IEA-GCCSI Workshop 20-21 April 2015, IEA Paris

In the past decade, much has been said about the nature and magnitude of liability for geologic storage of CO<sub>2</sub>. In response, a few governments enacted laws that assign and, in some cases, limit liability for geologic storage of CO<sub>2</sub>. Many others have not acted on the issue. The objective of this small workshop is to: review the latest findings on liability based on both research and actual project experience; re-evaluate the nature and magnitude of the problem and potential solutions; and, develop recommendations for governments that have yet to address liability for CO<sub>2</sub> storage. Discussions will be motivated by presentations, many of which are based on recent studies performed for the IEA and GCCSI.
