KNOW ALL MEN BY THESE PRESENTS, That we, _____ of

_____, a corporation organized and existing under and by virtue of the
laws of the State of _____ and having its principal offices at _____

_____, as Surety, are held and firmly bound unto the State of Maryland and
any aggrieved party in the penal sum of TWO THOUSAND DOLLARS (\$2,000.00) for which sum, well and truly to be
paid, we hereby bind ourselves, our heirs, executors, administrators, successors, and assigns, jointly and severally by
these presents:

WHEREAS, the Principal has obtained or is about to obtain license as a Water Conditioner Installer from the
Maryland State Board of Well Drillers, such license expiring on the 1st day of June of each odd calendar year; and

WHEREAS, under the provisions of Title 13 , Environment Article of the Annotated Code of Maryland and, as
amended, the Principal is required to file this bond with the Maryland State Board of Well Drillers in order to obtain
said license and carry on business as a Water Conditioner Installer in Maryland.

NOW, THEREFORE, the conditions of this obligation are such that if the Principal shall fully and faithfully
comply with all of the terms and conditions of said license and with all laws, rules, regulations and contracts relating to
the selection, installation and repair of water conditioning equipment or related materials used to change the chemical,
physical, or bacteriological characteristics of water obtained from a well, and any amendments thereto, then this
obligation shall be void; otherwise to remain in full force and effect.

PROVIDED, HOWEVER, that this Bond is executed subject to the following expressed conditions and
limitations:

1. This Bond is issued in accordance with the provisions of Title 13 , Environment Article of the
Annotated Code of Maryland. Should there be any conflict with the terms hereof, the statute or any
regulation promulgated pursuant to that statute shall prevail. This bond shall be effective from:

2. The Surety may cancel this Bond at any time by providing sixty(60) days written notice to the
Principal and the Maryland State Board of Well Drillers, it being understood that the period of
liability of the bond is two years after the submission of the last accepted permit document. Notice of
claims shall be given to the Surety within one year after either inactivation, expiration, or revocation
of the Principal's license or the cancellation of this Bond, whichever first occurs.

3. The aggregate liability of the Surety shall in no event exceed the penal sum of this Bond (\$2,000.00).
This Bond shall continue in full force and effect for the entire current license period and for any
renewals thereof unless the Surety gives notice of cancellation in compliance with paragraph 2 above.

4. A copy of this Bond, including any and all riders and endorsements executed subsequent to the
effective date of this Bond, shall be filed at all times with the Maryland State Board of Well Drillers.
