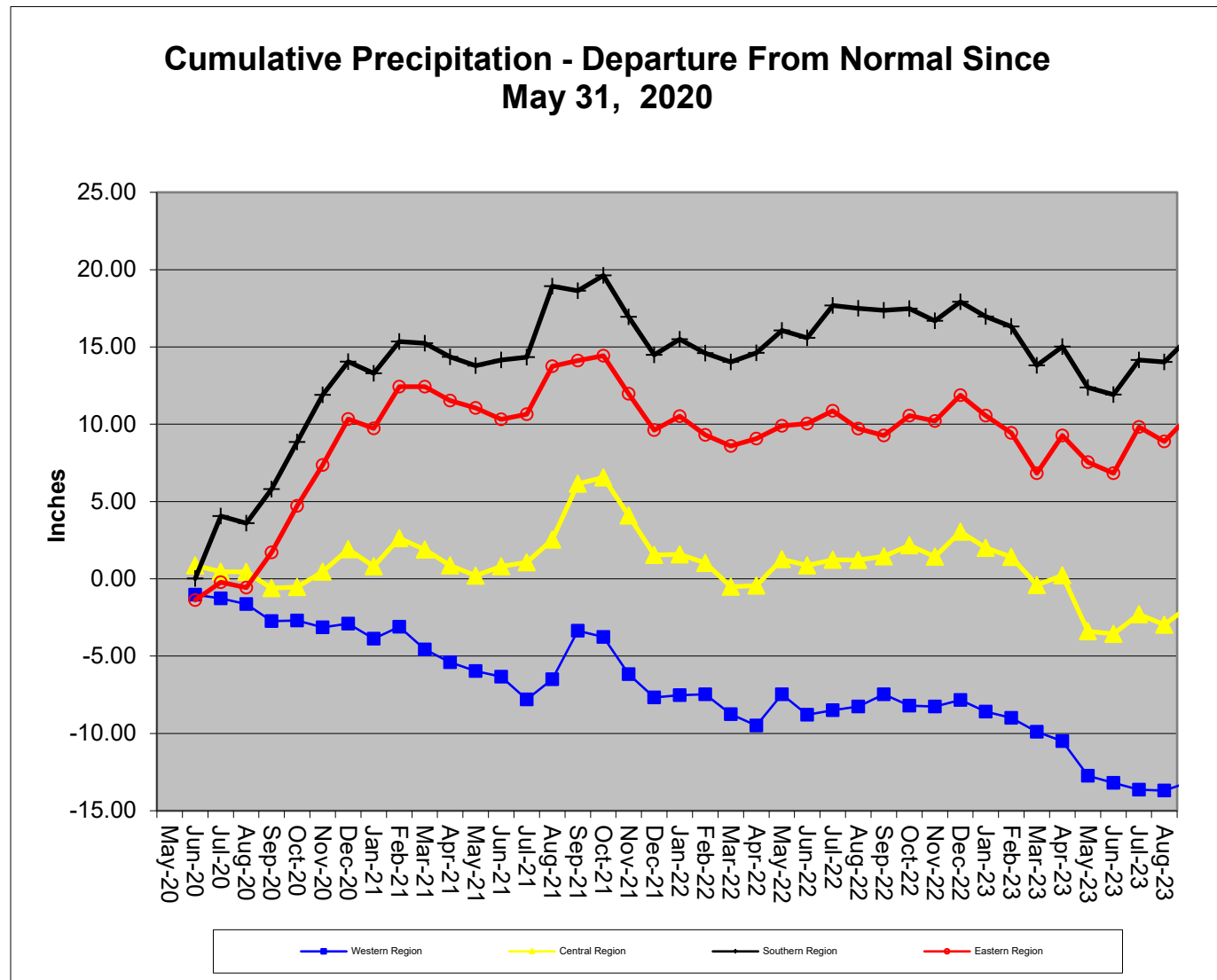

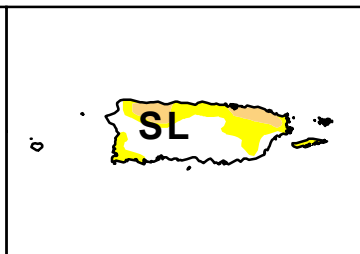
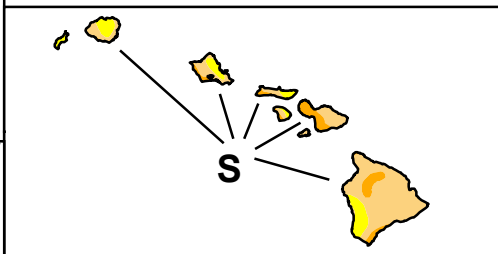
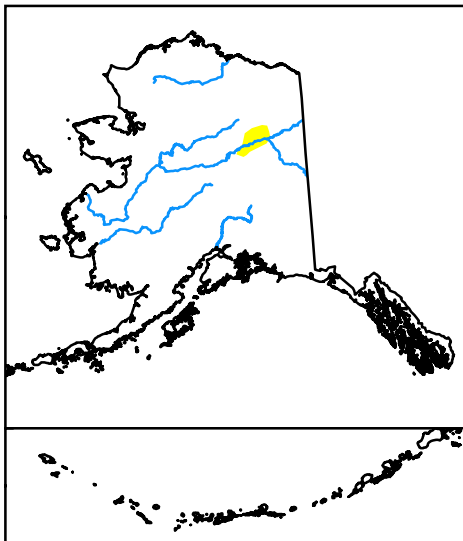
### Drought Impact Types:

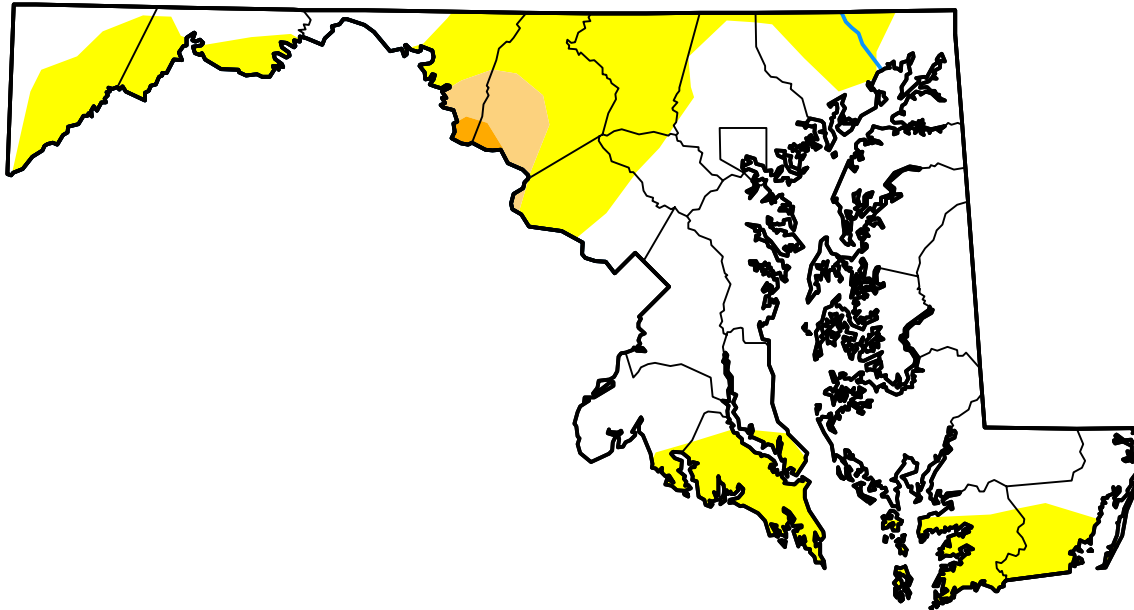
