Warranty Information

Armasight products are made for performance and durability and guaranteed to be free of defects in materials and workmanship under the Armasight Standard Limited Warranty. If your Armasight product is found to have defects in material and/or workmanship during the warranty period as described below, we will, at our sole discretion replace or repair the product, or provide a product of equal or higher replacement value, free of charge.

Armasight Standard Limited Warranty: Your Armasight product is guaranteed to be free of defects in materials and workmanship from the original date of purchase under the Armasight Standard Limited Warranty. The applicable Armasight Standard Limited Warranty period for each product is provided in the table below.

Armasight Extended Limited Warranty: Armasight products properly registered with Armasight within a period of 60 days from the date of purchase are eligible for extended warranty coverage, at no additional charge, extending the length of the warranty in accordance with the table below. Any products not registered with Armasight within 60 days of the date of purchase will only be covered by the Armasight Standard Limited Warranty.

Shipping, postage, transportation, insurance, duties, taxes and delivery are the customer's responsibility. To ensure proper delivery, we highly recommend that you utilize a carrier that offers shipment tracking and delivery notification and insurance (e.g., UPS, FedEx, USPS). We reserve the right to request proof of purchase and to evaluate the Armasight brand products for exclusions.
