Completion of Acquisition of MyAnimeList by US Subsidiary

MEDIA DO HOLDINGS Co., Ltd. (TSE 1st Section 3678, Headquarters in Chiyoda-ku, Tokyo, Representative Director and CEO: Yasushi Fujita, hereinafter "MEDIA DO HOLDINGS") announced MyAnimeList, LLC (head office: State of California, U.S., hereinafter "MAL") became a wholly owned subsidiary of Media Do International, Inc. (Headquarters in State of California, U.S., hereinafter "MD-i"). MEDIA DO HOLDINGS disclosed the decision to acquire MAL, doing business as "MyAnimeList," one of the world's largest anime and manga online communities, on January 15, 2019 and all the transactions relating to the acquisition were completed on March 1, 2019.

In addition, Atsushi Mizoguchi, CBO of MEDIA DO HOLDINGS, was appointed CEO of MAL effective March 1, 2019. The company is based in California, U.S., at the location of MD-i and will deliver various Japanese content to the world.
