The ECB shall assume the direct supervision of Oldenburgische Landesbank Aktiengesellschaft with effect from 1 January 2025.

(FR), and it is identified as one of the three largest credit institutions in Luxembourg.
Volksbank Wien AG	529900D4CD6DB3CI904	The application of the three-year rule has been interrupted in the case of Volksbank Wien AG (AT), as it once again met the size criterion as of the end of 2023, with total assets amounting above EUR 30 billion. Hence, the institution remains classified as significant based on the size criterion.
