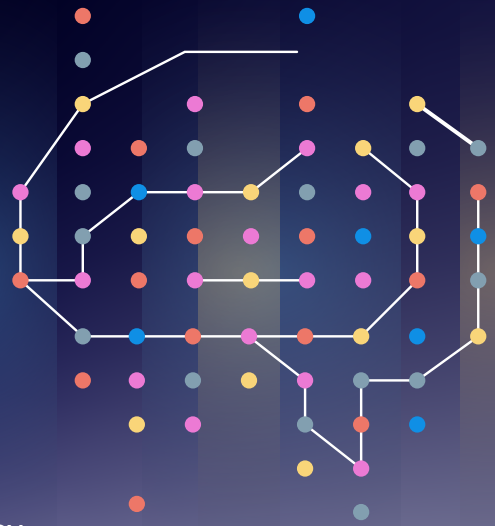

EDPS to adopt guidelines on the use of Generative AI by EU institutions and bodies

In the context of the growing use of generative AI, and as part of its supervisory role, the EDPS issues guidelines to the EU institutions and bodies on the application of relevant data protection principles.

EDPS to host Leadership event on AI in the EU institutions and bodies

In cooperation with the European School of Administration, the EDPS invites senior managers of EU institutions and bodies to learn and brainstorm about the use of AI.
