



Private Finance for Energy Efficiency (PF4EE) Instrument

Support provided under the Instrument as at 31 December 2022

As agreed in the Private Finance for Energy Efficiency (PF4EE) Instrument Delegation Agreement between the European Commission and the European Investment Bank (EIB), the EIB will publish information on Financial Intermediaries and Final Recipients supported and the procurement contracts signed under the PF4EE Instrument since the signature date of the Delegation Agreement (8/12/2014) until the end of 2022.
