#### 4.1.2 Efforts Sharing

As agreed at the Coordinators' meeting of 8 November, the Chair sent a letter to Mr Buzek, Chair of CCC, firmly opposing the request from AGRI committee to apply rule 54 to the Effort Sharing Regulation. The AGRI Committee has not reacted yet.
