#### 1. ADOPTION OF DRAFT AGENDA

The draft agenda was adopted in the form shown in these minutes.

### 2. CHAIR'S ANNOUNCEMENTS

#### 2.1 Main items discussed at last CCC

The Chair informed that the main item of last CCC was an exchange of views with Mr Verhostafdt, who updated the Committee Chairs on the situation on Brexit and asked input from committees on the key political issues that should be included in the EP resolution ahead of the European Council guidelines.

In relation to the Commission Work Programme 2017, it was announced at last CCC that the first Joint Declaration by the Commission, EP and Council had been adopted.

#### 2.2 Entry into force of new Rules of Procedure (constitutive meetings)

The Chair reminded that a revision of the Rules of Procedure was adopted during the December session and will enter into force next Monday. In relation to the constitutive meeting of committees, the Chair drew attention to new Rule 204 which provides that "The diversity of Parliament must be

reflected in the composition of the bureau of each committee; it shall not be permissible to have an all male or all female bureau or for all of the Vice-Chairs to come from the same Member State."

#### 2.3 Mission to China

The Chinese Mission has informally informed that the date chosen for the ENVI mission to China during the February turquoise week is not suitable given the current political climate, as reflected in recent resolutions on human rights adopted in plenary. The Chinese Mission suggested to postpone the ENVI mission to a turquoise week in the second half of the year (possibly July (17-21 July) or September (18-22 September). The Chair was mandated to write a letter to the Chinese Minister to support the ENVI request, in the light of the fruitful exchanges they had during the COP22 in Marrakech.

#### 2.4 Presence of MEPs in ENVI

The Chair asked coordinators to draw the attention of their Members to the problem of low attendance and asked them in future to ensure a good presence of Members at least from the group who requested to put the item on the committee agenda.

#### 3. DECISIONS ON URGENT MATTERS

- 3.1.1 TRAN Committee challenge of competence on the INI on International Ocean Governance

<u>Decision taken:</u> Coordinators mandated the Chair to reply to the letter, rejecting the request of the TRAN Committee.

Coordinators mandated the Chair to request the application of Rule 54, with exclusive competence of ENVI as regards sustainability criteria, greenhouse gas emissions savings and biofuels/ILUC (exact share of exclusive and shared competences to be agreed in written procedure).

meeting to have an exchange of views on the draft Commission

Implementing Decision.

upcoming Communication on the Environmental Implementation Review

in one of the first ENVI meetings in 2017.
