1. ADOPTION OF DRAFT AGENDA

The draft agenda was adopted in the form shown in these minutes.

2. APPOINTMENT OF MEMBERS TO COMMITTEE FOR ADVANCED THERAPIES (CAT) OF EMA

<u>Decision taken:</u> Coordinators endorsed the proposals made by the Commission (Mr Fibbe

and Mr Garcia as CAT substitute members and Mr Kamolz on the reserve

list) and mandated the Chair to inform accordingly the EP President.

3. CHAIR'S ANNOUNCEMENTS

3.1 Main items discussed at last CCC meeting

3.1.1 Exchange of views with the President of the European Court of Auditors (ECA), Klaus-Heiner Lehne

The Chair informed that she had transmitted by letter to the CCC the priorities indicated by the coordinators for ECA 2018 Work Programme. In the discussion at the CCC, Mr Lehne also indicated that, as ECA is currently reflecting on their strategy for the years 2018-2020, they would also be interested to hear from the different committees about mid- and long-term issues which they see as strategically important to be examined by ECA over the next three years.

Decision taken:

A deadline was fixed for <u>Thursday</u>, <u>23 March cob</u> for proposals for mediumlong term issues for ECA to look at, in view of a decision at the April coordinators' meeting.

3.1.2 Brexit

The Chair reported back on the exchange of views with the Brexit coordinator, Mr Verhofstadt at the last CCC meeting. As for the working documents that were agreed by coordinators in January, the Chair informed that replies have been received from the Commission and that they are going to be circulated to coordinators by the secretariat.

Decision taken:

Following a discussion, coordinators approved ENVI input for the EP resolution in view of the European Council guidelines.

In relation to the update of the working documents following the information received by the Commission, coordinators agreed to follow the same procedure which was used for drafting the working documents.

3.1.3 Joint Declaration on the EU's legislative priorities

The Chair informed that all Committees were asked to comment on progress of their specific files indicated as priority files in the Joint Declaration and that a working tool had been developed by the Commission for monitoring progress.

Decision taken:

Coordinators mandated the Chair to write to the CCC Chair expressing concern as for the form and content of the Commission working tool and stressing, in addition to the updates for those files indicated as priorities, the lack of progress from Council on other files such as cloning and the veterinary medecines package.

3.1.4 Input to CCC summary report in view of Commission 2018 Work Programme

Decision taken:

Coordinators confirmed the working method used last year (first draft by the secretariat based on ENVI last year's points not included in the Commission WP or not yet delivered; discussion at technical level with the political groups advisors; discussion/approval at coordinators' meeting at the beginning of May).

4. DECISIONS ON URGENT MATTERS

- 4.1 State of play of cooperation with other committees
- 4.1.1 Energy and Climate Governance

<u>Decision taken:</u> Coordinators decided to maintain the ENVI request for Rule 55 and mandated the Chair to write accordingly to the CCC Chair.

4.1.2 Renewables

ITRE accepts ENVI request for Rule 54. The details of the share of competence are still under discussion and will be submitted to coordinators in written procedure.

4.2 Draft programme for committee missions and ad hoc delegations during the second half of 2017

4.2.1 Missions to Agencies

Decision taken: Coordinators agreed to postpone the visit to EFSA to 18-19 December 2017

4.2.2 Missions other than Agencies

Decision taken: Coordinators decided to organise the following missions:

- IMO MEPC 71, Intersessional WG meetings on reduction of GHG emissions from ships, London, UK, 3-7 July
- Minamata Convention COP1, Geneva, Switzerland, 24-29 September
- Poland (climate/clean energy issues)
- Porto Marghera (Venezia, Italy), possibly combined with Gardanne, France (biofuel/biomass)

4.3 Participation of an EP delegation to COP 23 on climate, Bonn, November 2017

Decision taken:

Coordinators decided to request the Conference of Presidents to authorise on an exceptional basis, the sending of a 12-Member ad-hoc delegation to the high-level segment of the COP23 Climate Change Conference in Bonn, 14-17 November 2016. The 12 Members are to be nominated by the political groups in accordance with the rolling d'Hondt system, which shall also apply to the non-attached Members.

Coordinators also decided that ENVI will prepare, pursuant to Rule 128 of the Rules of Procedure, Oral Questions to the Council and the Commission plus a resolution in order to define Parliament's position ahead of COP23 (to be adopted in plenary by October part-session at the latest). As has been the case for previous COPs, the resolution could include contributions from other interested Committees, in particular ITRE.

A deadline for the communication of the <u>co-sponsors' names</u> to the secretariat was fixed for <u>Friday</u>, <u>16 March at noon</u>.

Finally, coordinators decided to request the Policy Department to commission a study on the issues at stake in view of the COP23 Climate Change Conference.

4.4 Action to safeguard ENVI prerogatives with regard to its exclusive competence on contaminants in fertilisers

<u>Decision taken:</u> Coordinators mandated the Chair to address the issue of ENVI exclusive

competence on contaminants with the other committees involved (IMCO,

INTA and AGRI).

4.5 Possible recommendation to JURI for an intervention by the European Parliament in a Court case brought by Sweden against the European Commission on an authorisation for the use of carcinogenic lead chromates in paint to a non-EU company

<u>Decision taken:</u> Coordinators asked the EP legal Service to provide their views in writing on

the matter by Friday 3 March. This information will be circulated to coordinators immediately in view of a rapid decision in written procedure

(before the 9 March coordinators' meeting).
