An Away Day of the CCC will take place on 7 June. The main items which will be discussed are Brexit (with Mr Barnier) and on a more practical note how to improve the procedure on conflicts of competence/Rule 54 and 55.

2.6 Shadows meetings in Strasbourg

Following restrictions on the EP budget for missions of committee secretariats, the possibility of organising shadows meetings in Strasbourg will have to be significantly reduced. Priority to use the limited possibilities available will be given to legislative files. Coordinators were asked to inform their Members of these restrictions.

• Case C-128/17, Republic of Poland v European Parliament and Council

The Republic of Poland brought an action against the European Parliament and the Council for the annulment of Directive (EU) 2016/2284 of the European Parliament and the Council of 14 December 2016 on the reduction of national emissions of certain atmospheric pollutants, amending Directive 2003/35/EC and repealing Directive 2011/81/EC ("NEC Directive").
