- I launched several Strategic Litigations before the EU and national Courts such as: the EU General Court dealing with legislative transparency (a) case T-540/15 on March 22nd 2018 against the EP on need of giving access to Trilogues' documents, (b) case T-163/21 on January 25th, 2023 against the Council of the European Union and dealing with the access to Council Working Group legislative preparatory documents) and (c) case T-590/23 on September 2023 on EU Legislative Transparency (art.15.2 TFUE) and against the Council of the European Union unlawful practice of limiting the access to legislative preparatory documents. Finally the Court of Justice ruling on the proportionality of the EU-PNR Directive (see Preliminary Ruling in case C-222/20).

Since 1/07/1998: In the Directorate-General Internal Policies (IPOL) of the EP I am the Head of the Secretariat of the Committee on Civil Liberties, Justice and Home Affairs (LIBE) which, since the enforcement of the Amsterdam Treaty (1999), has been in charge of all the EU Freedom, security and Justice area (AFSJ) related policies as well of the implementation in the EU of the European Charter of Fundamental Rights.

(1998 -1996) In the Directorate-General Presidency of the EP I was in charge of the Interinstitutional relations Service (DG Presidency) which monitors the inter-institutional decisionmaking process. At inter-institutional level, I was substitute Member of the Management Committee of the Office for Official Publications of the European Communities (Publications Office-OPOCE). Under this capacity, I actively and successfully supported the free access by citizens to the electronic version of the Official Journal (via a new Internet Portal EURLEX) and to the European Community Legislation database (CELEX).

(1996 - 1994) In 1994 (entry into force of the Maastricht Treaty) I have been associated at the first EP co-decision-conciliation Unit and I was in charge of the DC II Unit responsible for the

internal referral ("saisines") of the Council Common Positions and Commission proposals to the parliamentary committees. In 1996 I was responsible for the EP second generation informatics legislative workflow (ITER - still operational). To make such work more reliable and traceable also to general public, I launched the external re-diffusion communication tool (OEIL - Observatoire Européen Institutionnel et Législatif - Legislative Observatory).

(1994 1987) After the entry into force of the Single European Actin 1987 I assisted the rapporteur (Christopher Prout) on the revision of the EP internal Rules (notably the Chapter V on legislative procedures) and for DG II I was charged of the secretariat of the first Interinstitutional Coordination Group (so called "Groupe Neunreither"). In this capacity I was charged also of the establishment of the first EP informatics work flow tool (AP-TECOM project) and I contributed to the establishment of the first collection of "models" (templates) for Parliamentary acts to be used try the translation services and to the negotiations of the first inter-institutional legislative programs.

(1987 -1985) From 1 May 1985 to 1987: I worked in the Directorate- General II (Parliamentary committees and delegations) for several parliamentary committees dealing with Transports, Rules and Petitions, External Policies, Legal Affairs and Regional Cohesion.

From 1975 to 1980, as representative for the Lombardy Region's Secretariat, I took part in the working groups charged of the Reform of the Italian Public Administration as foreseen by the Italian Law 387/75. The working groups participated at the drafting of Presidential Decrees (DPR 616/77 and 617/77) which revised the competences (exclusive and shared) between the Regions and the National Ministries

From 5/10/1971 to 15/12/1973 I worked in the Cabinet of the President of the Lombardy Regional Government.
