Who we are

Our mandate is to:

- Shape the CFP by providing evidence-based recommendations;
- Support the EC by delivering scientific advice prior to the preparation of legislation proposals in the field of fisheries, aquaculture, and related matters.
- -Track the evolution of the CFP and promote the exchange of best practices.

Based on the Commission Decision of 25 February 2016

• STECF is composed by 30-35 persons appointed every 3 years by the Commission:

"highly qualified scientific experts, in the application of marine and fisheries biology, fishing gear technology, fisheries economics, fisheries governance, ecosystem effects of fisheries, aquaculture or in the field of collection, management and use of fisheries and aquaculture data."



- Meets 3 times a year in Plenary: Spring, Summer and Autumn.
- Expert Working Groups EWG,
 - No fixed participation, although an attempt to have 2 STECF members, at least.
 - EWGs report to STECF.



- Written procedures, now substituted by mini-plenaries. Only one TOR. 1-3 per year. Urgency/timeframe.
- In 2024 we have had 22 meetings in total:

 3 Plenary, 3 mini-Plenary and 16 EWGs.

- Only the Commission/DG MARE can request advice from STECF
- We are supported by JRC:
 - Handling the secretariat (Commission role)
 - JRC data collection team (Commission role)
 - As independent experts/chairs with DOIs (none Commission role).
 - For each EWG a JRC focal point is designated
