1. ADOPTION OF DRAFT AGENDA

2. CHAIR'S ANNOUNCEMENTS

2.1 Main issues discussed at last CCC

The largest part of the meeting was devoted to the finalisation of the procedure of the hearings of the Commissioners.

2.2 Update on TTIP

On 24 July 2014, the coordinators expressed again the wish of insisting on 2 ENVI representatives one from EPP and one from S&D (Mr Herbert DORFMANN (EPP) and Mr Guillaume BALAS (S&D)). No response has been received from INTA yet, as it is the European Commission who has established the number of people to have access to the confidential documentation. The subject was also widely discussed during the last TTIP Coordination Group organised by President Schulz on 14 October 2014. Another point made by the INTA Chair and discussed at that meeting was the possibility to launch an INTA report in accordance with Rule 108 of the Rules of Procedure to be eventually voted in plenary in February 2015. That report will however need to be authorised by the Conference of Presidents.

With regards the negotiations, the 7th round of negotiations took place in the US between 29.9-3.10.2014. Mr Bercero, the EU chief negotiator, briefed the INTA Monitoring Group on 15 October 2014 and informed that the issues addressed during those negotiations were the sectors of pharmaceuticals, motor vehicles, chemicals. There are still no joint texts on the table. The horizontal chapters on regulatory coherence and sustainable development will be discussed at the 8th round. However, as more preparations are needed for the preparation of those chapters, Mr Bercero does not expect the next round to take place earlier than January 2015.

2.3 Expo 2015

The AGRI Committee has appointed a standing rapporteur. Both the AGRI and ITRE Committees plan to send delegations to Milan in the first semester 2015. ENVI will have to discuss at one of the next coordinators' meetings its possible involvement.

The EU has only competence in that field as far as setting a common procedural framework through Council Directive 89/105/EEC, the "Transparency Directive" to ensure that national pricing and reimbursement decisions are made in a transparent manner and do not disrupt the operation of the internal market. The revision of the Directive has been for years now blocked in Council). The Chair was mandated to reply accordingly to the author of the MfR.
