4.2 ENVI Committee missions in the second semester 2015

<u>Decision taken:</u> The following missions were decided/confirmed:

• ECHA, 3 Members (S&D, ECR, EPP): max 2 days between 20-24 July;

- EFSA, 3 Members (S&D, ALDE, EPP): 24-25 September;
- Taranto, 5 Members + Chair (S&D, ECR, EPP, S&D, ALDE Italian Members can join at their own-expenses): max 3 days between 3-6 November;
- ad hoc committee delegation to 27th MOP to the Montreal Protocol, Dubai, 3 Members (EPP, S&D, EPP): max 3 days between 1-5 November.

4.3 Participation of Members' assistants to committees' missions

<u>Decision taken:</u> Coordinators mandated the Chair to raise the issue of

Member's assistants' participation to missions with the

appropriate EP bodies.

4.4 Scrutiny and oversight activities of the ENVI Committee

Decision taken: Coordinators endorsed the draft scrutiny plan as a whole.

In addition, coordinators took the following specific

decisions:

Exchanges with Members of the Court of Auditors: Coordinators agreed that decisions on the procedure applicable to an ECA special report (exchange of views in Committee for example) are to be taken on a case-by-case basis; coordinators agreed to organise a presentation in committee concerning the forthcoming ECA special report on the emissions trading system;

Implementation reports: Coordinators decided to draw up an implementation report on Mining Waste (EPP, 1 point). Additional topics for implementation reports can be proposed later in the year as no quota exists any longer for this kind of reports;

Rolling check-list on transposition deadlines and review clauses in EU legislation: Coordinators instructed the secretariat to prepare and regularly update such a list.

4.5 Possible exchange of views with EFSA on bisphenol A

<u>Decision taken:</u> Coordinators dismissed the request from Ms D'Ornano,

Goddyn, Mélin and Mr Jalkh without excluding to deal with the issue of bisphenol A in another form at a later stage.

4.6 Possible exchange of views with ECDC and WHO on vaccination policies in EU Member States

<u>Decision taken:</u> Coordinators agreed to the above request.

4.7 Possible INI report on harmonised systems of national identification and registration of pets

<u>Decision taken:</u> Coordinators mandated the Chair to write to the

Commission asking information, by next coordinators meeting, on the state of play and on the results of the study that the Commission should have conducted following the Schnellhardt report. On the basis of this information an OQ

in plenary could be considered as a follow-up.
