**Proposal for a regulation****Article 7 – paragraph 7 a (new)***Text proposed by the Commission**Amendment*

***7 a. By 31 December 2025, the Commission shall present a report to the European Parliament and to the Council in which it shall examine the availability of recyclates and the benefits of a credit-based system, in particular for small and medium-sized enterprises. If appropriate, the report may be accompanied by legislative proposals to include a credit-based system to ensure that producers can comply with the requirements of paragraphs 1 and 2 by purchasing credits from overachieving producers of other products of the same polymer type and increase the targets set out under this Article to compensate the increased flexibility for producers to comply with the targets set out in these paragraphs.***

**Proposal for a regulation****Article 22 – paragraph 1***Text proposed by the Commission**Amendment*

1. Economic operators shall not place on the market packaging in the formats and for the purposes listed in Annex V.

1. **From 1 January 2030**, economic operators shall not place on the market packaging in the formats and for the purposes listed in Annex V **unless:**

**(a) such placing on the market is in line with Article 4(2) of Directive 2008/98/EC; and**

**(b) they can show effective collection for recycling of those packaging formats, on the basis of the predominant packaging material, at least 85% by weight by 2028 and every year thereafter.**

**Proposal for a regulation****Article 26 – paragraph 13 a (new)***Text proposed by the Commission**Amendment*

***13 a. Economic operators shall be exempted from the obligation to meet the targets in paragraphs 1, 3a, point (a), 3b, point (a) and paragraph 8 of this Article, when the rate of recycling of the packaging material as reported by the Member States to the Commission under Article 50(2) point (c) is above 85% by weight of such packaging placed on the market on the territory of that Member State in the calendar year 2027 or any calendar year thereafter.***
