Justification

In SDG target 12.3 the EU and its Member States committed to "By 2030, halve per capita global food waste at the retail and consumer levels and reduce food losses along production and supply chains, including post-harvest losses". Already in 2017, the European Parliament called on Member States to "take the measures required to achieve a Union food waste reduction target of 30% by 2025 and 50% by 2030".

- 1 a. Member States shall take the necessary and appropriate measures to achieve, by 31 December 2035, the following targets at national level:
- (a) reuse of 30 % of waste textile, textilerelated and footwear products listed in Annex IVc;
- (b) recycling of 40% of waste textile, textile-related and footwear products listed in Annex IVc;
- (c) fibre-to-fibre recycling of 10% of waste textile, textile-related and footwear products listed in Annex IVc;
- (d) a reduction of the generation of textile waste by 10% in comparison to the amount generated in 2030.

Justification

In its resolution on the EU Textiles Strategy, the Parliament underlined "that the revision of the Waste Framework Directive should introduce specific separate targets for textile waste prevention, textile collection, textile reuse, preparation for reuse, closed loop fibre-to-fibre recycling and phase out the landfilling of textiles". If further reiterated "the need for an absolute decoupling of growth from resource use in the textile sector and its request for the Commission to propose binding EU targets for 2030 to significantly reduce the EU's material and consumption footprints and bring them within planetary boundaries by 2050, using the indicators adopted as part of the updated monitoring framework". The Parliament called "on

the Commission to propose comprehensive science-based targets for the textiles sector without delay, in order to measure the sector's transition to circularity, including on the use of raw materials".
