The President of the European Court of Auditors, Mr Tony Murphy, will present the main conclusions of the annual report of the Court for the financial year 2023.

According to Article 287 TFEU, the ECA draws up an annual report at the end of each financial year. This report, including the statement of assurance (DAS - Déclaration d'Assurance) concerning the reliability of the accounts and the legality and regularity of the underlying transactions, is considered by the Council and the Parliament in the framework of the discharge procedure under Article 319 TFEU.

The presentation of the European Court of Auditors Annual Report is a decisive point in the discharge cycle related to the year 2023. It will be followed by an exchange of views with the Directors-General of the Commission on 17 October and subsequent hearings of Commissioners related to each of the MFF-headings. Upon examination of all relevant documents and the hearings, Parliament will decide in spring 2025 - acting on a recommendation from the Council - whether to grant discharge to the Commission, other Institutions and other EU bodies in respect of the implementation of the EU budget for the year 2023, including the NextGenerationEU programme.

In the Annual Report, ECA issues an opinion concerning the reliability of the accounts, and several opinions on the legality and regularity of the transactions underlying the accounts: These opinions comprise one for revenue, one for expenditure and one for the RRF. A central element in these assessments, which are particularly relevant for the discharge procedure, is the error rate calculated by the ECA on the basis of their extensive audit work on the compliance of EU revenue and expenditure with rules and regulations, the budgetary and financial management and the particular audit findings and conclusions for the different MFF headings. ECA calculates an overall error rate and specific error rates for some of the major spending areas. Since last year, the Court has re-established the practice of reporting on performance in chapter 3 of the Annual Report, replacing the separate annual report on performance that was published for the financial years 2019 to 2021.

The 2023 Annual Report as well as the 2023 EU Audit in brief will be published on Thursday, 10 October 2024. It will also be available on the [CONT website](#) after publication.

The integrated financial and accountability reporting package (IFAR) brings together comprehensive information on the implementation, performance, results, sound financial management and protection of the EU budget for the financial year 2023. It consists of five reports:

- the 2023 Annual Management and Performance Report and its annexes provide an overview of the performance, management and protection of the EU budget, including the performance and compliance aspects of the Recovery and Resilience Facility (RRF);
- the 2023 Consolidated Annual Accounts of the European Union contain financial information on the activities during the year;
- the Report on the Follow-up to the Discharge for the 2022 financial year is a first, rather political reply to the 2022 discharge report, indicating how the Commission proceeds with the requests made by the European Parliament and the Council of the European Union in the discharge procedure of the previous year. A detailed follow-up, replying to all recommendations made, will

follow later in 2024;

- the Commission Report to the Discharge Authority on Internal Audits carried out in 2023 presents a synthesis of the recommendations made by the Internal Audit Service (IAS) and the actions taken on those recommendations to improve the Commission's governance, risk management and control processes;
- the Long-term Forecast of Future Inflows and Outflows of the EU Budget (2025–2029) provides the payments and revenue forecast covering the multiannual financial framework (MFF), and the European Union Recovery Instrument – NextGenerationEU (NGEU).

The year 2023 was characterised by ongoing support for Ukraine from the EU, most notably through the creation of the Ukraine Facility. This Facility was created as part of the mid-term review of the MFF 2021–2027, which also provided additional financial support for migration and border management, defence related projects and additional funds for external action that resulted in the creation in 2024 of the Western Balkans' Facility.



In 2023, the final adopted budget amounted to EUR 181.8 billion of commitment appropriations and EUR 160.5 billion of payment appropriations. NGEU reinforced the key programmes by an additional EUR 238 billion of commitment appropriations. Outstanding commitments (commonly referred to as RAL – *reste à liquider*), which are committed amounts not yet paid, stood at EUR 543.0 billion at the end of 2023, compared to EUR 452,8 billion at the end of 2022, an increase of 19,9 %, mainly caused by the additional funds committed from the RRF. The Commission predicts that the RAL will decrease from 2024 onwards, reflecting the advancing implementation of the RRF and the MFF 2021–2027.
