In order to support Moldova in its economic recovery and its process towards joining the EU, the Commission adopted on 9 October 2024 a growth plan for Moldova, similar in its aims when compared to the growth plan for the Western Balkans. The Moldova Growth Plan comprises three pillars, one of which is the increase of financial assistance through a dedicated Reform and Growth Facility for Moldova.

The AFET and BUDG Committees are the lead committees for Parliament’s position on the Commission’s proposal for a regulation of the European Parliament and of the Council on establishing the Reform and Growth Facility for the Republic of Moldova (hereafter the ‘Facility’). CONT and INTA committees contribute as opinion giving committees under Rule 57 RoP.

In this draft legislative opinion, the CONT rapporteur expresses his support for the Facility, including its performance based nature, as it provides good building blocks for the protection of the EU Financial Interests. He also acknowledges the Commission’s efforts to keep in this Facility most of the legal provisions that were agreed by the co-legislators on the Western Balkans Facility, including with regard to the protection of the EU’s financial interests.

The rapporteur, however, considers that the Commission’s proposal can still be improved on matters such as: the amounts for the pre-financing and technical and administrative assistance, proportion of grants vs loans, the role and capacities of the Moldova’s Court of Accounts in the framework of the Facility, transparency, or prevention of reversal of measures or non-fulfilment of preconditions, among other.

Under the current schedule, the AFET and BUDG committees will vote on their report on 30 January 2025, while the vote on the CONT opinion is scheduled on 27 January.

The Gender Equality Week provides an opportunity for the parliamentary committees and Parliament in general to discuss how the 2020-2025 EU Gender Equality Strategy is implemented in the different policy areas of the EU. During this exchange of views, the CONT Committee will focus on how gender equality is mainstreamed in the EU budget.

CONT members will be updated on the latest state of play of the different initiatives developed by the European Commission in the area of gender budgeting, such as the methodology to measure expenditures related to gender at EU programme level. Gender budgeting is a tool that helps to establish gender equality and gender mainstreaming. It redistributes the budget rather than increases it with the aim of focusing on measures with the highest impact on gender. The CONT members will hear the Commission about its prospects regarding the next developments of the methodology and will discuss how to harmonise the requirements across programmes under the next multi-annual framework with an aim to ensuring that gender equality is efficiently and effectively mainstreamed.

The CONT Committee will hold a hearing with Commissioner Serafin in the context of the discharge procedure for the Commission for financial year 2023. This hearing is traditionally the last hearing concerning the Commission discharge and is the occasion for the European Court of Auditors to present a wrap-up of their audit work for the year.

Budgetary and financial management is covered by chapter 2 in the ECA's Annual Report. ECA concluded that during 2023 most of the available commitment and payment appropriations were used, with EUR 184,4 billion in commitment appropriations (out of EUR 186,5 billion available) and EUR 162,0 billion in payment appropriations (out of EUR 165,2 billion available) used.

Commitments under the NGEU funds were EUR 115,6 billion, while payments (NGEU grants and top-ups to MFF funding programmes) were EUR 74,7 billion.

Outstanding commitment reached an all-time high, with EUR 304,4 billion from the EU budget and assigned revenue other than the NGEU and EUR 238,6 billion from the NGEU, totaling EUR 543 billion.

The total nominal value of outstanding EU borrowing increased in 2023 from EUR 348 billion to 458,5 billion. For the NGEU the EU may borrow an additional EUR 443,6 billion until the end of 2026.

The Court's reporting on performance of the EU budget continues to be reported separately in chapter 3 in the annual report. This chapter provides an overview of key messages of Special Reports from 2023, an analysis of how the Commission reports on performance for MFF heading 4 "migration and border management", an analysis of the implementation of recommendations made in the Court's 2020 report on performance of the EU budget, and the implementation of recommendations from the Court's Special Reports published in 2020.

Revenue, amounting to a total amount of EUR 248,4 billion, is covered by chapter 4 in the ECA's Annual Report. ECA concludes that the level of error in revenue was not material. The Court also points to actions from the Commission's Customs Action Plan to be lagging which delays the possibilities to reduce the "customs gap".



Administration is covered by chapter 10 of the ECA's Annual Report. Spending on administration amounted to EUR 12,3 billion in 2023. The Court notes that this amount comprised spending on human resources and pensions (about 70 % of the total), buildings, equipment, energy, communications and information technology. ECA concludes that the overall audit evidence indicates that the level of error in spending on administration was not material.

In accordance with the timetable for the discharge procedure, the written questions for this meeting were sent to the Commission on 22 November 2024, answers are expected to be received on 4 December and will be forwarded to the CONT Members immediately.

It is proposed that the hearing with Commissioner Serafin proceeds as follows:

- Introductions by the reporting Members of the European Court of Auditors, who will present the findings of the Annual Report 2023 in the relevant areas;
- Commissioner Serafin will reply to this introduction;
- CONT Rapporteurs and shadow rapporteurs will put questions to the Commissioner and the ECA followed by answers (the ping-pong system);
- Other Members will question the Commissioner and/or the ECA;
- Closing remarks by the Commissioner, CONT Rapporteur and the Chair.
