## 1. Chair's announcements

### The Coordinators:

- **heard the Chair announce that Coordinators' notes and supporting documents will continue to be made available through a dedicated online portal, accessible to the Chair, the Vice-Chairs, the Coordinators, Political Group Advisers and Secretariat staff.**
- **heard the Chair inform them that in the upcoming meetings in September, several nominations for Members to certain bodies are upcoming, including:**
  - **the Board of Trustees of the House of European History, for which, in addition to the Chair, a second Member should be appointed as a full Member to the Board.**
  - **the Commission's informal expert group on cultural heritage, for which two CULT members and two substitutes should be appointed.**
  - **the Panel for the Future of Science and Technology (STOA), for which one Member should be appointed.**
  - **the inter-committee network on the implementation of the UN Convention on the Rights of Persons with Disabilities, or EP CRPD Network, for which a Member and a substitute representative should be appointed.**

## 2. Calendar of meetings

AST: KF

**Decision:**

- The Coordinators approved the calendar of CULT meetings for the second half of 2024 as suggested.

## 3. Linguistic profile

AST: KF

**Decision:**

- The Coordinators approved the linguistic profile of the CULT Committee as suggested.

## 4. Budget procedure for 2025

AD: DC/DS

**Decisions: The Coordinators:**

- agreed to maintain the same working method for the rest of the Budget 2025 exercise and to mandate the Chair to take charge of it until the end of the procedure.
- agreed with the timetable for the 2025 budget procedure as proposed.
- agreed to exceptionally work in English only, but recalled the importance of working in all languages as a standard practice.
- endorsed all new PP-PAs submitted in the correct format and clearly outlining the proposed action and justification by 24 July, noon.
- agreed to restore the budget on the budget lines that fall within the CULT remit, where there are cuts by the Council.
- agreed to provide the CULT opinion for the October budgetary procedure in the form of a letter.

## 5. CULT Missions – second half of 2024

- **The Coordinators agreed with the deadline of 4 September 2024, close of business, for political groups to send proposals for Members interested in participating in this mission.**

## 6. Points system for appointing rapporteurs for reports & opinions

AD: MF

The Coordinators decide on whether a report or opinion is drawn up by a given parliamentary committee, and which group is entitled to nominate a rapporteur: this decision is then presented to the full Committee for its approval.

Where possible, the Coordinators try to reach these decisions by consensus. In the event of disagreement between coordinators, reports and opinions in CULT have traditionally been attributed on the basis of a points system that reflects the strength of each group represented in the committee.

The CULT Committee has been using a points system for several terms already. During the 9th term, several coordinators' decisions have been taken that have a bearing on the points system. It could therefore be updated to reflect these decisions and experiences from the last legislature.

**The Coordinators took note of this point for information. It will be discussed in September.**

## 7. CULT political priorities for the 10th legislature (2024-2029)

AD: FA

On 9 April 2024 the former CULT Chair and the CULT Coordinators strongly recommended to continue the 2019-2024 practice as regards the establishment of political priorities.

In the new term, the **purpose of the CULT political priorities** could be twofold:

1. A strategic guidance for the CULT Committee in terms of high level political coordination and agenda-setting in relation to the Commission and the Council (e.g. to provide input in relation to the hearings of the Commissioners-designate; a guidance document for future scrutiny activities, for the structural dialogue with the Commission, and for follow-up of the work of the Council Presidencies);
2. Streamlining the internal work of the Committee on a more operational level, i.e. to guide the decisions on own-initiative reports, committee public hearings, workshops, studies, etc.

**Format:** The CULT political priorities could be a concise document that could be reviewed on a regular basis, or at least every 2,5 years. In order to allow for flexibility and proper monitoring in the future, annexes could be added to indicate progress towards achieving the CULT political priorities and to indicate the list of commitments made at the hearings of the Commissioners-designate. The political priorities could be accompanied by a list of policy actions, formulated broadly in order to make it more explicit how the priorities will be deployed.

**Timing:** With a view to discussing the future CULT priorities at one of the next Coordinators' meetings, a draft proposal could be sent by the Chair by 6 September 2024 at the latest. Political groups will then be invited to submit their comments on the draft proposal to the CULT Secretariat by **20 September 2024, at 12:00**. If additional proposals would need to be put forward and considered by the Coordinators, it would be important that political groups provide an explanation on their rationale and importance. Following the suggestions received, a first discussion could take place at the **end of September** and possible endorsement by the Coordinators could take place in **October**.

## 8. Smooth and effective committee work

AD: MF

In order to ensure that the work of the CULT Committee is smooth and effective and that committee procedures work as transparently and efficiently as possible, it is suggested that the Members of the CULT Committee agree to apply and abide by a number of principles, based on good practices of the previous terms. The last committee mandated the CULT Secretariat to compile relevant Coordinators' decisions taken during the 9th term and the relevant recent decisions of the Conference of Presidents and the Bureau following the 2024 reform of the Parliament, against the backdrop of the existing 'CULT Quality Charter' of the 9th term. Based on this compilation, an updated Quality Charter could be envisioned.

### 9.1. Proposal for a Council recommendation on a European Quality Assurance and Recognition System in Higher Education – 2024/0079(NLE)

COM(2024)0147

This is one of two proposals for Council Recommendations accompanying the Commission communication on a blueprint for a European degree (see point 4.2 below for the second proposal). It deals with a European Quality Assurance and Recognition System in Higher Education and aims to contribute to the automatic recognition of qualifications, for which trust is a pre-requisite. Therefore, the proposed measures include strengthening quality assurance systems across the board. For alliances of higher education institutions that wish to offer joint degrees (e.g. European Universities alliances), a cross-institutional quality assurance approach should be developed, with outcomes of cross-institutional quality assurance to be recognised in national quality assurance systems, avoiding the need to fulfil additional requirements at national level. Joint programmes offered by such alliances could then be eligible to award a ‘European degree’, provided that they match a set of European criteria (linked to transnational programme organisation and management, learning experience and European values, see Annex II of the proposal). In addition, national quality assurance agencies should be allowed to award a preparatory ‘European label’ to joint programmes that fulfil said European criteria.

***Recommendation:*** *Treat together with the proposal under 9.2; see there for recommendation and decision to be taken.*

## 9.2 Proposal for a Council Recommendation on attractive and sustainable careers in higher education – 2024/0078(NLE)

This is the second proposal for a Council Recommendation on attractive and sustainable careers in higher education, accompanying the above-mentioned Commission communication. It aims to help attract and retain talent in academia, seen as an enabling condition for delivering the European degree. This means ensuring that staff enjoy working conditions where they can strive, regardless of their personal background, and enjoy academic freedom in line with democratic principles. In such a working environment, staff should help deliver high-quality and inclusive education, the pioneering of new joint transnational educational activities and ensuring knowledge sharing and the provision of relevant skills. To facilitate such work, the proposal tackles the uneven recognition of the diverse roles academic staff take on in addition to research, e.g. teaching, developing transnational education activities or micro-credentials, and mainstreaming sustainable development.

On 9 April 2024, the previous CULT Coordinators decided to abstain from taking action on the two files under points 3.1 and 3.2 before the elections and mandated the Chair to send a letter to the Council Presidency, requesting the timetable for adoption to leave ample time for the CULT committee to provide its stance after the elections.

While there was no response to that letter, the Belgian Presidency did start informal discussions on this file in the first half of 2024. However, it is likely that the recommendation will not be adopted under the Hungarian Presidency, and adoption is rather expected during the first semester of 2025, under the Polish Presidency. This would allow the CULT committee to provide a considered response to the package.

On 15 November 2023, the European Commission published a proposal for a Regulation of the European Parliament and of the Council ‘Establishing an EU Talent Pool’, which introduces a regulatory framework for the creation of an EU-wide platform aimed at facilitating international recruitment and providing opportunities for jobseekers from third countries that are interested in working in occupations for which there are EU-wide shortages.

The LIBE Rapporteur on this file, Ms Al-Sahlan had communicated her intention to opinion giving Committees that she would seek a mandate before the end of the term. The decision not to pursue this timetable in LIBE was communicated when work in CULT had already reached a very advanced stage and so the opinion was put to the vote in CULT.

Should LIBE decide to pursue this report in the 10th term, the new rules stipulate that in such cases, and if so authorised under the new modalities of cooperation, the CULT Committee may prepare a new opinion, as it is technically not possible to add an opinion from the 9th term to a report adopted during the 10th term. The CULT Secretariat will keep its Members informed accordingly.

**10.2. Proposal for a Directive of the European Parliament and of the Council on combating the sexual abuse and sexual exploitation of children and child sexual abuse material and replacing Council Framework Decision 2004/68/JHA (recast)**

On 6 February, the Commission published a legislative proposal to recast the Directive on combating child sexual abuse and sexual exploitation, as part of the EU Strategy for a more effective fight against child sexual abuse (2020-2025).

At the CULT Coordinators' meeting on 13 February 2024, CULT Coordinators decided to “draw up an opinion in the form of a letter in English only, should LIBE decide to deal with this proposal in the current legislative term”. On 22 February, LIBE decided to allocate the file to Mr Lenaers as Rapporteur, but apart from the presentation of the draft report on 18 April 2024, the proposal will be dealt with in the 10th legislative term. The CULT Secretariat will keep its Members informed accordingly, depending on the application of the new Rules of Procedure and any transitional measures on the unfinished business package.

Responding to Parliament's legislative own-initiative report entitled 'Quality Traineeships in the Union (2020/2005(INL))' and together with the Commission proposal for a Council Recommendation on a reinforced Quality Framework for Traineeships (see below), this proposal for a directive is intended to create a reinforced Quality Framework for Traineeships. The proposed directive has two specific objectives, namely (1) ensuring non-discrimination of trainees in comparison to comparable workers in the same establishment (unless a different treatment is justified on objective grounds), and (2) combating regular employment relationships disguised as traineeships, requiring Member States to provide for effective checks and inspections to detect such regular employment arrangements, with indicative elements set out at EU level. It would apply to trainees who have an employment relationship (as defined by law, collective agreements or practice in force in the Member States, regardless of the type of traineeship). It also aims to ensure good quality learning content for traineeships and sets out

that ‘information [...] on learning and training elements need to be included in vacancy notices and advertisements of traineeships.’

While recognising EMPL’s competences and the focus of the proposal on employment aspects, CULT’s responsibility for the wider youth policy and the lifelong learning components of traineeships must not be neglected.

On 9 April 2024, the Coordinators decided to draft an opinion and to request association pursuant to the at-the-time Rule 57 of the EP’s RoP. You can find the exchange of letters of the CULT and EMPL Chair with the CCC regarding the mode of cooperation for this file. The proposal will be dealt with in the 10th legislative term. The CULT Secretariat will keep its Members informed accordingly, so that the file can be allocated and an opinion can be prepared, depending on the application of the new Rules of Procedure.

This proposal for a Council Recommendation on a reinforced Quality Framework for Traineeships goes together with the proposal for a Directive on improving and enforcing working conditions of trainees and combating regular employment relationships disguised as traineeships (see above under point 4.2). It aims to extend the Quality Framework to all kinds of traineeships, also those that are part of formal education and training curricula and regardless of the employment status of the trainees, and its main objective is to improve the quality of traineeships, in particular learning and training content and working conditions. To achieve this end, it recommends, *inter alia*, to lay down the above elements in a written agreement and assign a supervisor or mentor to the trainee. It also sets out that traineeship providers cannot require candidates to have previous work experience and it deals with the recognition of traineeships.

On 9 April 2024, the Coordinators mandated the Chair to inform the CCC and EMPL Chairs that adequate involvement of CULT (pursuant to the old Rule 57 or Rule 58 of the EP’s RoP or to the new Rule 57 or 59) is expected, should EMPL decide to draw up an own-initiative report on this topic in the 10th parliamentary term.

EMPL has not yet decided whether to respond to this proposal and in which form. In case EMPL decides to respond, CULT should request an opinion pursuant to Rule 57 or Rule 59 for an own-initiative report or contribute to any other possible initiatives or replies. In this case, the CULT Secretariat will keep its Members informed accordingly so that the necessary

steps can be taken.
