Written declaration, under Rule 136 of Parliament's Rules of Procedure, on preventing childhood obesity¹

- 1. The World Health Organisation considers childhood obesity to be one of the most serious global public health challenges.
- 2. In spite of the campaign to promote healthy lifestyles and combat obesity, the percentage of overweight children remains extremely high in Europe, where in 2010, according to a WHO study (Childhood Obesity Surveillance Initiative), one child in three was overweight or obese.
- 3. According to the 'EU Action Plan on Childhood Obesity 2014-2020', approximately 7% of European health budgets is spent on the treatment of diseases linked to obesity, which cause roughly 2.8 million deaths a year.
- 4. The Commission and the Council are therefore called upon to:
 - work towards harmonised Europe-wide data collection and analysis;
 - monitor the policies to fight obesity as set out in the action plan and their outcomes in terms of prevention;
 - encourage exchanges of data and best practice among Member States.
- 5. This declaration, together with the names of the signatories, is forwarded to the Council and the Commission.

¹ Under Rule 136(4) and (5) of Parliament's Rules of Procedure, where a declaration is signed by a majority of Parliament's component Members, it is published in the minutes with the names of its signatories and forwarded to the addressees, without however binding Parliament.
