Written declaration, under Rule 136 of Parliament's Rules of Procedure, on the differences in declarations, composition and taste of products in Eastern and Western markets of the  $EU^{\rm 1}$ 

- 1. Some studies have confirmed differences in the composition and quality of products on eastern and western markets in the EU.
- 2. It has been demonstrated that many products sold on 'eastern' markets are of much lower quality and contain far fewer high-quality ingredients than those sold on western markets. This problem affects a wide range of products from food and toiletries to detergents and disinfectants which are of inferior quality to 'identical' products in the western segment of the EU market.
- 3. While the EU is engaged in negotiations with the USA on the Transatlantic Trade and Investment Partnership (TTIP), its own single market is still far from uniform.
- 4. Accordingly, the Commission is called upon to:
  - (a) undertake market research in order to improve its understanding of the scale of product inequality and its causes;
  - (b) collect and publish data in a public document;
  - (c) in partnership with European consumer protection institutions, propose possible solutions to end consumer discrimination in eastern Member States.
- 5. This declaration, together with the names of the signatories, is forwarded to the Council and the Commission.
