Written declaration, under Rule 136 of Parliament's Rules of Procedure, on the urgent need to raise intervention prices in order to stem the crisis in the dairy sector¹

- 1. The dairy sector is going through critical times in the European Union, with the low prices paid to producers posing a threat to the survival of thousands of farms that cannot cover their production costs.
- 2. Europe cannot afford to abandon sector which is of strategic importance to the rural economy, generates activity and employment, and is essential to tying people to the territory.
- 3. The measures proposed by the Commission are a step in the right direction but are not sufficient, especially for those farms in the worst situation.
- 4. The Commission is hence called upon to approve an increase in intervention prices as a matter of urgency in order to restore a balance in the market, and to monitor the proper functioning of the industry and the distribution within the value chain, which will result in a rise in the prices paid to farmers.
- 5. This declaration, together with the names of the signatories, is forwarded to the Council and the Commission.
