Subject: Transparency of funds, funding to neo-fascist movements and Pro Vita & Famiglia's compliance with EU transparency register rules

An investigation by the newspaper *Domani*<sup>1</sup> has revealed the opaque financial relations between the non-profit organisation Pro Vita & Famiglia and the neo-fascist party Forza Nuova (FN), as well as an exponential increase in donations to the former, whose balance sheet reveals precious little financial information<sup>2</sup>. The investigation has uncovered recurring financing and donations, including cheques, bank transfers and the purchase and provision of real estate, linked to Pro Vita & Famiglia – also from Swiss accounts – to the FN and other far right-affiliated-bodies and entities.

Given the fact that since 19 September 2024 Pro Vita & Famiglia has been listed in the EU's transparency register as a 'non-profit-making' body (registration No 188449993594-21) and the ethical and behavioural rules enshrined in the code of conduct which it has signed and undertaken to observe, the principle of transparency laid down in European Union law and in the Treaties and the meeting that body held with Italian MEPs on 17 September 2024 at the European Parliament<sup>3</sup>, could the Commission say whether:

1. The interests declared by Pro Vita & Famiglia in the transparency register are in compliance with its rules, and has any improper use of the register has taken place?
2. The information provided is complete, up-to-date, accurate, not misleading and in the public domain?
3. The information stated about all parties involved and the relationship with third parties are compliant with the rules and entirely in the public domain?
