## Question for written answer E-000063/2025 to the Commission Rule 144 Giuseppe Antoci (The Left), Carolina Morace (The Left)

Subject: Organised crime's involvement in sporting events and its infiltration of supporter groups

The increasing involvement of criminal organisations in sporting events raises major concerns about the integrity of sport in Europe. Recent events in  $Italy^1 - a$  country where *ultra* supporter groups provide fertile ground for criminal elements and mafia organisations – indicate that these infiltrations are a cross-cutting issue and threaten the socio-cultural values inherent in sport<sup>2</sup>.

Recent investigations show that sports have been widely infiltrated by criminal groups by means of match-fixing, illegal betting and the adjudication of contracts relating to sporting events and facility management, an example being the operation of the parking areas set aside for prestigious competitions (including the 2026 Winter Olympics<sup>3</sup>) and major European football fixtures. This state of affairs has highlighted that the alarming convergence of sport and crime could threaten the safety and integrity of sporting events.

The Council of Europe's Convention on the Manipulation of Sports Competitions<sup>45</sup> is a cornerstone in the fight against corruption in sports, as is Recommendation CM/Rec(2018)12 promoting 'good governance in sport' and urging Member States to apply 'a zero-tolerance policy regarding corruption.'

Given that concrete EU action is needed in this area:

- 1. Will the Commission back legal and legislative action<sup>6</sup> specifically designed to combat organised crime in sports?
- 2. What specific initiatives could the Commission take to ensure greater cooperation between law enforcement agencies, judicial authorities and sports governing bodies and clubs at the European level?
