Subject: VP/HR - Harassment of the LGBTI community in Egypt

Egypt is experiencing a wave of repression against LGBTI people. Last week 33 Egyptian citizens were arrested at a public bath after being accused of 'libertinism' and practising 'immoral and indecent acts' amongst men. Last month, eight Egyptian men were condemned to a three-year prison sentence for simulating a gay wedding. Numerous NGOs are warning about the Abdel Fattah el-Sisi government's use of social media to crackdown on the homosexual community.

- 1. What actions does the VP/HR plan to develop to defend equal rights for LGBTI people in Egypt and demand a cease in attacks towards this community?
- 2. Will the VP/HR work to guarantee asylum rights in the EU to citizens persecuted in third countries for their sexual orientation, as EU regulation states and as the Court of Justice has expressed?
- 3. Is the European External Action Service providing the European Asylum Support Office and Member States with the information gathered by EU delegations on the situation of LGBTI people in third countries?
