**Decisions taken at the meeting:****1. Allocation of reports and opinions****1.1. Resumption of dossiers of the 9th legislature**

- *Coordinators decided that no renewed proposal should be requested from the Commission nor the Commission should be recommended to withdraw any of the proposals in the EMPL remit.*

**1.1.1. European statistics on population and housing, amending Regulation (EC) No 862/2007 and repealing Regulations (EC) No 763/2008 and (EU) No 1260/2013 - 2023/0008 (COD)**

- *Coordinators reconfirmed the Renew group for the rapporteurship and invited the other groups to appoint shadow rapporteurs swiftly.*

1.1.2. Amending Regulation (EC) No 883/2004 on the **coordination of social security systems** and Regulation (EC) No 987/2009 laying down the procedure for implementing Regulation (EC) No 883/2004 - **2016/0397 (COD)**

- *Coordinators reconfirmed the S&D group for the rapporteurship on the revision of the Coordination of the Social Security Regulation and invited the other groups to appoint shadow rapporteurs swiftly.*
- *Regarding the screening of unfinished business exercise, Coordinators decided to resume the file and continue the trilogue negotiations at the point where they failed (in line with Coordinators' Decision of September 2019), taking into account the progress achieved during the 9th mandate (in line with Coordinators' decision of February 2024).*

1.1.3. Establishment and functioning of **European Works Councils** and effective enforcement of transnational information and consultation rights Amending Directive 2009/38 - **2024/0006 (COD)**

- *Coordinators reconfirmed the EPP group for the rapporteurship on the revision of the European Works Councils Directive and invited the other groups to appoint shadow rapporteurs swiftly.*
- *Regarding the screening of unfinished business exercise, Coordinators decided to resume the file where it was left (after adoption of draft report on 3 April 2024, vote in committee on the mandate was postponed).*

1.1.4. Improving and enforcing working conditions of trainees and combating regular employment relationships disguised as traineeships (**'Traineeships Directive'**) - **2024/0068 (COD)**

- *Coordinators reconfirmed the committee's stance on the conflict of competence with CULT.*
- *Coordinators reconfirmed the S&D group for the rapporteurship on the Traineeships Directive and invited the other groups to appoint shadow rapporteurs swiftly.*

1.1.5. Establishing an **EU Talent Pool - 2023/0404 (COD)**

- *Coordinators reconfirmed the S&D group for the rapporteurship on the EU Talent Pool and invited the other groups to appoint shadow rapporteurs swiftly.*
- *In respect of the transitional arrangements, Coordinators decided to request that the proposal should be dealt with under the joint committee procedure pursuant to Rule 59.*

1.1.6. **European labour market statistics on businesses**, repealing Council Regulation (EC) No 530/1999 and Regulations (EC) No 450/2003 and (EC) No 453/2008 of the European Parliament and of the Council - **2023/0288(COD)**

- *Coordinators decided to reconfirm the S&D group for the rapporteurship on the European labour market statistics on businesses and invited the other groups to appoint shadow rapporteurs swiftly.*

#### **1.1.7. Long-Term Residents Directive (recast) - 2022/0134 (COD)**

- *Coordinators decided to reconfirm the Renew group for the rapporteurship on the Long-Term Residents Directive and invited the other groups to appoint shadow rapporteurs swiftly.*

- *Coordinators decided to attribute the report to EPP.*

#### **1.2.2. Proposal for an own-initiative report on the future of the European Social Fund**

- *Coordinators decided to invite the Commission for an exchange of views in the committee.*

1.2.9. Communication from the Commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee of the Regions: **Labour and skills shortages in the EU: an action plan** - COM(2024)0131

- *Coordinators decided to organise an exchange of views once the new Commission is established to discuss the legacy of the European Year of Skills and possible further actions in this field.*

#### **5. Activities with national parliaments**

- *Coordinators decided to postpone the decision to the next Coordinators' meeting, planned for the 03/10/2024.*

#### **6. Scheduling of coordinators meetings second semester 2024**

- *Coordinators took note of the proposed dates of coordinators meetings for the second half of 2024: 3 October, 14 October, 12 November and 12 December 2024.*

#### **7. Exchange of views with Agency Directors**

- *Coordinators took note of the current state of preparations for the exchange of views due to take place on 14 October 2024, which will be finalised in a written procedure.*

#### **8. Mission to Poland**

- *Coordinators took note of the current state of preparations for the mission to Poland in the week of 28 October 2024 (week 44).*

letter, the coordinators decided to appoint Ms Romana TOMC as provisional representative of EMPL for the first meeting of the Budget Network;

- In respect of the **FEMM request to draw up an opinion to the EMPL European Semester report** under Rule 57, Coordinators raised no objections (deadline 23/09/2024) to replying favourably to the request.

## 10. Any other business

### 10.1. EMPL resolution on the need for jobs and workers' rights protection in restructuring processes : the case of Audi Brussels

- *Coordinators decided to draw up a resolution on the social consequences of the restructuring in the automotive industry in Europe (generally and not on only one individual case) with a special focus on workers, and assigned the sponsorship to S&D (title of the resolution and timetable to follow).*

- *Coordinators were debriefed by the Chair on the current state of preparations of the confirmation hearings.*

### 10.3. Housing

- *The Chair was mandated by Coordinators to defend EMPL competences in the CCC in respect of housing.*
