The meeting opened on Thursday 17 October 2024 at 14.39, with Javier Zarzalejos (Chair) presiding.

1. Adoption of agenda

Point of order:

A point of order was raised by András László in connection with the postponed items “*Hungarian Presidency of the Council of the European Union, 2024*” and “*The Situation of the Rule of Law in Hungary*”

MEP László, on behalf of the PfE group, expressed their disappointment at the decision to postpone the exchange of views with the Hungarian Presidency despite the Presidency availability to participate in the meeting and to make their presentations and considered the decision as unfair.

The Chair reminded that the decision of the Coordinators was to extend an invitation to the Hungarian Ministers of Interior and Justice to present the priorities of the Presidency together with a follow up exchange of views on the rule of law in Hungary, particularly on aspects related to interior and justice. Following contacts with the Permanent Representative, the Chair had to postpone the point, as the two ministers wished to have the EOV together with their colleague dealing with European Affairs, who was unavailable. The Chair had to reiterate that while the Minister of European Affairs was welcome, LIBE would not agree to shift the scope of the exchange of views to Article 7 proceedings in accordance with the institutions' prerogatives on the matter (Hungary being a MS under Art 7.1 proceeding). A renewed invitation was extended to the HU Ministers for 21 November.
