## 1. Welcome & Chair's announcements

Coordinators fully endorsed the Chair's proposal for a minutes' silence at the beginning of the PECH meeting, in respect of the shipwreck of the fishing vessel "Argos Georgia" in Falklands' waters in the southern Atlantic, with the loss of nine seamen.

## 2. Overall Guidelines

### 2.1.1 Agenda & Attendees to Coordinators' meetings

**Decision:** Coordinators agreed by large majority to invite Vice-Chairs to attend Coordinators' meetings in a consultative role, as well as to allow for one APA for Chair/Coordinator to be present if needed.

**It is reminded that Coordinators decide by consensus, or if a vote is taken, a decision must cover at least a "large majority" (Rule 220(2)) defined in PECH at 2/3 of PECH Members (= 18/27). For this purpose, draft Recommendations adopted are circulated to Members and Group Advisors by the Secretariat after each meeting (EN only). At the end of the Committee meeting or by a later deadline, if no objections are raised, they are deemed adopted by the full Committee.**

**Decision: In view of the summer recess, Coordinators endorsed the Chair's suggestion to request extension by two months (until 18 November and 22 November) for all four Delegated Acts, to allow for a proper scrutiny time.**

## 7. Missions

The Conference of Presidents will adopt new implementing provisions on EP missions; in the meantime committee missions to international conferences may be requested ad hoc.

### 7.1 Missions in the 2nd half of 2024

#### 7.1.1. GFCM Annual Meeting - Rome (FAO HQ), 4-6 November 2024

PECH Committee participates every year with 3-4 Members included in the official EU delegation attending the Annual Meeting of the General Fisheries Commission for the Mediterranean (GFCM).

#### 7.1.2 ICCAT Annual Meeting - Limassol, Cyprus, 14-17 November 2024

PECH Committee participates every year with 3-4 Members included in the official EU delegation attending the Annual Meeting of the International Commission for the Conservation of Atlantic Tunas (ICCAT).

**Decision: Coordinators agreed to send a delegation of 4 Members (including Chair) to the GFCM & ICCAT Annual Conferences scheduled in November. Groups should nominate participating Members by 27 September to allow for timely accreditation.**

## 7.2 Missions & Delegations in the 1st half of 2025

**Decision: Requests for missions for the 1st semester 2025 will have to be submitted to the CCC probably in October: Coordinators are invited to submit mission proposals by 27 September 2024.**

## 8. Public Hearings

**Decision: Suggestions for a public hearing in the December PECH meeting will have to be submitted by 27 September 2024. A list of hearing subjects for 2025 could be established later.**

## 9. Any other business

### 9.1. Voting lists

Votes in Committee take usually place on Tuesdays or Wednesdays, and draft voting lists are circulated by the secretariat to Group advisors as early as possible, as agreed with the Rapporteur, allowing for a reasonable deadline for comments. In PECH, final voting lists - including compromise amendments and rapporteur's indications (if available) - were so far circulated by the secretariat no later than 48 hours before the vote (= Friday 09.00 for Tuesday votes, Monday 09.00 for Wednesday votes).

**Decision: Coordinators agreed to continue with this procedure.**

### 9.2. Appointment of a "Standing Rapporteur" for EU-UK TCA

In the past term, PECH had appointed a Member as "Standing Rapporteur" to follow Brexit-related issues and the implementation of the fisheries chapter in the EU-UK Trade & Cooperation Agreement (TCA).

Coordinators are invited to remind Members of their Groups of the obligation for all committee office holders (Chairs, Vice-Chairs, Rapporteurs, Shadow-Rapporteurs) as well as participants to missions or inter-institutional negotiations, to comply with the rules on conflicts of interest (DACI declaration).
