**Decision: This report was allocated to the S&D Group for 0 points “on rotation”.**

#### **2.2 Opinions**

- 2.2.1 **Protection of animals during transport** and related operations - COM(2023)770 - 2023/448(COD) (*NB: unfinished business reconfirmed for 10th term by AGRI/TRAN; PECH opinion in 9th term had been attributed to Greens/EFA*)

**Decision: Coordinators confirmed the decision, by large majority, to draft an opinion to this AGRI/TRAN file and to allocate it to the Greens/EFA Group that had bought it in the last term, for 0 points.**

#### **2.3 Fisheries Partnership Agreements (NLE-files)**

The Rapporteur for the consent procedure to approve the new Protocol (2024-2029) to the **SFPA EU-Guinea Bissau** (2024/0159 (NLE)) requested authorisation to draft an **accompanying non-legislative resolution** (M-NLE).

**Decision: Coordinators approved the request to draft an accompanying non-legislative resolution.**

### 5. **Missions**

#### 5.1. **GFCM Annual Meeting - Rome (FAO HQ), 4-6 November 2024**

The mission of 4 Members was authorized by the CoP on 19 September. The question of a potential clash with the Commissioners-designate confirmation hearings will be resolved once we know the hearings' calendar (*tbc asap*).

**Decision: Coordinators approved the list of participants as detailed in Annex I and mandated the secretariat to launch the accreditation, if the mission can take place.**

#### 5.2. **ICCAT Annual Meeting - Limassol, Cyprus, 14-17 November 2024**

The mission of 4 Members was authorized by the CoP on 19 September.

**Decision: Coordinators approved the list of participants as detailed in Annex II and mandated the secretariat to launch the accreditation.**

### 6. **Confirmation Hearings** (*see full details of rules in Annex VII RoP*)

The confirmation hearings of Commissioners-designate are organised by the CoP based on a recommendation of the CCC that met today; the CoP will then take a final decision on the calendar of hearings and the repartition of responsibilities tomorrow 2 October (afternoon).

**Decision: The Chair informed Coordinators on the procedure and by a large majority of Groups obtained a mandate to request in the CCC meeting:**  
- PECH be the sole responsible for the hearing of Mr. Kadis, with ENVI invited;  
- PECH be invited to the hearings of Ms. Suica (Mediterranean) and Mr. Hansen (Agriculture and Food Security). A request was also expressed for PECH to be invited to the hearing of Mr. Varhelyi (Health and Animal welfare).

## 7.2. Various Appointments

**Decision: Coordinators approved the appointments hereunder as detailed in Annex III.**

### 7.2.1 Appointment of a two Representatives to the EFCA Board

Coordinators may consider appointing a representative and a substitute to the Administrative Board of the European Fisheries Control Agency (EFCA), as foreseen by the new Fisheries Control Regulation.

### 7.2.2 Appointment of a “Standing Rapporteur” for EU-UK TCA

Coordinators may consider appointing a Member as “Standing Rapporteur” to follow Brexit-related issues and the implementation of the fisheries chapter in the EU-UK Trade & Cooperation Agreement (TCA).

### 7.2.3 Petitions Network

Coordinators may consider appointing a Member participating in the PETI Committee “Petitions Network” and, if needed, report on petitions submitted to PECH.

### 7.2.4 Gender Mainstreaming Network

Coordinators may consider appointing a Member to oversee issues related to gender balance in committee activities and participate in the FEMM Committee “Gender Mainstreaming Network”.

### 7.2.5 Appointment of a “Standing Rapporteur” for budgetary issues

Coordinators may consider appointing a Member to the “Budget Network” coordinated by BUDG and CONT Committees.

### 7.2.6 Appointment of two EP Representatives to the CNML Board (France)

Coordinators may consider appointing a representative to the Board of the “Conseil national de la mer et des littoraux” (CNML) to replace the outgoing EP representatives. According to a CoP decision, the two designated Members have to be agreed among the PECH, ENVI and TRAN Committees.
