### **1. Chair's announcements**

### **2. Commissioner-designates confirmation hearings (UPDATE)**

The replies to the Written Questions to the Commissioners-designate are expected on 22 October. The timetable for the confirmation hearings, as adopted by the CoP, was circulated. Various practical aspects are summarized in *Annex I*. Members' speaking time for the hearings will be allocated exclusively by Groups. Members can participate in all confirmation hearings (and ask a question if they obtain speaking time from their Groups). For "Invited Committees" only the Chair may present an oral question on behalf of the Committee.

**Decision: Groups should elaborate by 24 October one oral question (plus one question in reserve) for each of the two confirmation hearings to which PECH is invited (i.e. Fitto & Hansen). They need to be adopted (written procedure) by 30 October latest.**

### **3. INI-Reports**

During the first half of a parliamentary term, committees may simultaneously draft up to six own-initiative reports. Implementation reports and legislative own-initiative reports (based on art.225 TFEU) are not subject to this ceiling.<sup>1</sup>

**Decision: Coordinators decided, by large majority, to select 4 INIs plus 2 Implementation Reports, as listed in *Annex II*, for which CoP authorization will be requested.**

**The Chair invited the Legal Service to clarify in writing the voting rules in Coordinators' meetings, as a previous vote among coordinators on 4 INIs plus 1 Implementation Report ended with a majority of 14 in favour, 12 against.**
