- 2.1 Proposal for a Council Decision on the conclusion, on behalf of the European Union, of the **Implementing Protocol (2025-2030)** to the **Sustainable Fisheries Partnership Agreement (SFPA)** between the European Union and the Government of **Greenland** and the Government of Denmark.  
COM(2024)0479 - 2024/0263(NLE) (SFPA >10m€/year)

**Decision: Coordinators allocated this file to The Left Group for 0,5 points; they also approved by large majority an eventual request to draft an accompanying non-legislative resolution to this agreement, if requested by the Rapporteur.**

- 3.6 **The impact of the implementation of MSP Directive 2014/89/EU on fisheries and aquaculture in selected fishing areas and sea basins**

**Decision: Coordinators allocated this file to the Renew Group for 1 point.**

#### 4. **Opinions**

- 4.1 **PECH opinion** (in form of a letter) on **fisheries related protocols with Norway and Iceland** - 2024/52(NLE) - INTA lead committee

A draft opinion, elaborated in close consultation among the Groups, is in *Annex I*. Council submitted to Parliament four different Agreements and Protocols as one package, even though the legal basis were different and negotiations had taken place separately. As a result, we can only adopt or reject the package as a whole. The PECH draft opinion proposes two different options to be voted in Committee: one asking for the rejection of the fisheries protocol with Norway (hence rejecting the whole package); one suggesting the adoption of the whole package, including both fisheries protocols.

**Decision: As none of the two options proposed in *Annex I* obtained a large majority, Coordinators agreed to put both options to the final vote in Committee on 28 January.**

- 4.2 **PECH opinion** to the INI "A revamped long-term budget for the Union in a changing world" - 2024/2051(INI) - BUDG lead committee

This BUDG INI aims at elaborating a position for the future MFF 2028-2034. As the CCC deadline to ask for a formal opinion had expired already, the only option remaining is to draft an opinion in form of a letter addressed to BUDG. However, this opinion would not have an official file number.

**Decision: Coordinators agreed to draft an opinion in form of a letter to the BUDG INI on the future MFF 2028-2034 and charged the PECH Standing Rapporteur for Budget to coordinate this task. Not being an official opinion, exceptionally no points are to be paid for this.**

#### 5. **Documents received for information**

- 5.1 Proposal for a Council decision fixing for **2025 and 2026 the fishing opportunities** for certain fish stocks, applicable in Union waters and, for Union fishing vessels, in certain non-Union waters - COM(2024)506 - 2024/0285(NLE)

**Decision: Given the importance of the subject, Coordinators invited the Chair to add a debate on the proposed TACs and reductions of fishing effort in the Mediterranean to the PECH agenda of 5 December; addition approved in Committee under item 2 (Adoption of the Agenda).**

**Decision: Coordinators did not request an extension of scrutiny deadlines on the three Delegated acts; however, they mandated the Chair to address a letter to the Commission deploring the systematic abuse of the TACs & Quotas Regulations to adopt technical measures bypassing the EP.**

The CoP has not yet adopted the new implementing provisions for 2025 EP missions; that means that each mission still has to be authorized individually *ad hoc*.

### 7.1. PECH mission to Pieria, Greece (25-27 February 2025)

The S&D Coordinator proposed a mission to northern Greece (see *Annex II*); the final programme and list of participants could be approved on 28 January.

**Decision: Coordinators agreed on the destination proposed by S&D for the mission**



**in February, and the secretariat is instructed to start the formal request asap. Interested Members must sign up by 11 December cob.**
