6.1 PETI Annual Report 2023

6.2 PETI Opinion to the upcoming JURI request for an own-initiative report on “Monitoring the application of European Union Law”

Coordinators decided to mandate the Chair to ask the CCC for an opinion under Rule 57 as soon as JURI request for drafting an INI report on Monitoring the application of European Union Law is notified to the CCC.

7. PETI Fact-Finding Visit (FFV) to Austria (14-16 April)

Coordinators agreed to have one AGRI Member and one ENVI Member participating as accompanying Members in the Fact-Finding Visit to Austria on the wolf population and on amending the EU Deforestation Regulation foreseen for the green week of April 2025 (14-16 April).

8. Follow-up on Petitions Nos 0298/2022 and 0349/2022 discussed by PETI Committee on 14 November 2024

‘In case of multiple requests on the same B-item proposing different actions to be taken, including the granting of two months to the petitioner to provide additional information, the Coordinators will vote on all requests.’

11. Request by the GREENS/EFA group to set up a PETI Working Group on "Strengthening inter-institutional dialogue to improve the handling of infringement procedures linked to the Petition process" (in line with Point 9 of PETI Guidelines)

The majority of Coordinators decided not to set up a PETI Working Group on "Strengthening inter-institutional dialogue to improve the handling of infringement procedures linked to the Petition process".

12. Appointment of PETI Members for the Mainstreaming Network on Policy Coherence for Development (PCD)

Coordinators appointed Rosa Estaràs Ferragut (EPP group) as the PETI Focal Point for Policy Coherence for Development in the EP Network on Policy Coherence for Development.

13. PETI Annual Research Programme 2025

Coordinators agreed with the proposed procedure for the adoption of the PETI Annual Research Programme for 2025.

The Coordinators of the S&D and the Greens/EFA groups disagreed with reopening and repeating the vote on the Greens/EFA request on Petition No 0961/2024.
